

WHEREAS, the Mohawks of Akwesasne have the existing and inherent right of self-determination, which includes the inherent jurisdiction over their lands, peoples and territory;

AND WHEREAS, the Mohawks of Akwesasne have aboriginal and treaty rights, and other rights and freedoms that are recognized and affirmed in the Constitution of Canada, which include the inherent right of self-determination and jurisdiction over their lands, peoples and territory;

AND WHEREAS, the Mohawk Council of Akwesasne is the community government within the territory of Akwesasne and has inherent jurisdiction to make laws, regulations and policies to meet the needs and concerns of the Mohawks of Akwesasne;

AND WHEREAS, the Mohawk Council of Akwesasne intends to preserve the cultural, political and economic integrity of the Mohawk territory and community of Akwesasne;


WHEREAS, historical objectives of the Mohawk Council of Akwesasne have included expansion of the community's economic base, and the advancement of its own self-government;

AND WHEREAS, although unrelated, these two objectives have resulted in a common need for the Mohawk Council of Akwesasne to acquire additional property in order to offer land to prospective industrial and commercial developers, and in order to provide its own administration with needed facilities;

AND WHEREAS, the acquisition of such additional property should be subject to research in order to confirm that all financial, physical and legal requirements can be met prior to its purchase;

AND WHEREAS, it is in the community's best interest that such research should be conducted by competent technicians within the administrative structure of the Mohawk Council of Akwesasne;

THEREFORE BE IT RESOLVED THAT, the Chief Administrative Officer is hereby instructed to create a permanent Property Acquisition Team, consisting of one senior member of Administration, one senior member of the Finance Program, one senior member of the Department of Technical Services, one senior member of the Office of Vital Statistics, a lawyer from the Justice Department and a Chief designated by Council, and a manufact of Environment

FURTHER BE IT RESOLVED THAT, the mandate of the Property Acquisition Team is to participate in all aspects of property acquisition, (without limiting the generality of the foregoing) including: identifying potential purchases, determining suitability, negotiating the purchase price, confirming financing and petitioning Mohawk Council for authority to effect the actual purchase.
