





# MCA & CBSA BORDER COLLABORATION INITIATIVE UPDATE

MCA would like to share an overview and updates with the community on the MCA & CBSA Border Collaboration Initiative (BCI).

#### **BACKGROUND**

The MCA-CBSA Border Collaboration Initiative was officially launched in January of 2020, as a result of ground-breaking "design-thinking" sessions that were held to identify challenges and opportunities for collaboration between Akwesasne & CBSA. Design Thinking is a strategic method of designing or improving a service or product with the user in mind. It encourages an organization, for example, to consider who they are creating services for, which then naturally improves the user experience.

Through open and honest dialogue between Government of Canada and Akwesasne officials, a co-developed vision for potential solutions emerged from the two-day Design Thinking workshop with all parties supporting user-based improvements. With a commitment from CBSA leadership to work together toward solutions, our initiative has forged ahead.

The initiative included the first Work Plan with immediate improvements such as enhancing service capacity at the POE through an increase in staffing, along with medium- and long-term improvements, such as exploring options to improve processing for domestic travelers and to support economic development.



#### **PHASE 1 WORK PLAN**

BCI (Border Collaboration Initiative) consists of several working circles. Our Phase 1 Work Plan which was implemented ongoing from 2020 until 2022 included the following circles:

1. The Leadership Circle – The CBSA president at the start of the initiative John Ossowski, MCA Grand Chief Abram Benedict, and delegated representatives from both organizations meet on a quarterly basis to discuss new and ongoing work in the initiative and to address high-level issues that require discussion. The other members of Council who sit on various circles of the initiative are Chief Julie Phillips-Jacobs, Chief April Adams-Phillips, Chief Vanessa Adams, Chief Vince Thompson, Chief Sarah Sunday-Diabo, and Chief Cindy Francis-Mitchell.


- 2. The Governance Circle is the administrative hub of the initiative coordinating the work going on throughout the initiative. They also report the work of the working circles up to the Leaders Circle.
- Domestic Lane Working Circle this circle was created at the start of the initiative with a clear and specific purpose to create a domestic lane for those travelling through the port who haven't left Canada. With MCA & CBSA discussing all areas of the Domestic Lane from logistics to community concerns, to signage, the Domestic Lane Pilot Project launched at the end of 2020. Recently, the Domestic Lane Pilot has been deemed permanent and is no longer a pilot project. While minor issues exist with the Domestic Lane, it has significantly reduced the wait times for non-international traffic and has helped to alleviate wait times for both domestic and international traffic. We recognize that residents of Kana:takon and Tsi Snaihne believe the lane should be for any Akwesasne traffic, but the current location of the port of entry does not allow for this to happen. Future plans for the border and pre-clearance may allow for new changes that accommodate the broader Ak-
- 4. Community Relations Working Circle The purpose of this circle is to build a more positive relationship between the community and CBSA. It includes exploring opportunities for CBSA to support the youth and Akwesasne community members and events. This past year CBSA attended and sponsored a meal for MCA's Missing & Murdered Indigenous People event. The Community Relations Working Circle also includes the development of a calendar so CBSA can be aware of any events that are upcoming which might require additional staff and lanes to open, as well as for CBSA to plan for their own participation and attendance in order to have a more positive/less intimidating presence in our community.

In this circle, MCA & CBSA worked together on Orange Shirt Day campaigns, which included the commissioned artwork of Joe King for the Orange Shirt Day hand logo that is used at CBSA ports across the country.

The Community Relations Working Circle also includes development of documents,

signage and messaging to improve the flow of information. A driver's guide booklet was developed early on which provides those travelling through Akwesasne with information on what identification is needed at the border. This circle has plans next to develop an economic development-based brochure to outline border processes for those shopping in Akwesasne.

Through the Community Relations Working Circle we began smoothing out a process for communication that has been successful in ensuring the Akwesasne community is notified of changes at the port that may cause delays such as when they experience technical difficulties. Opening the lines of communication has allowed these urgent messages to flow regularly and quickly.

5. Economic Development Working Circle – Due to multiple factors, the economic development priorities were merged into the Community Relations Working Circle.

#### **PHASE 1 SUMMARY**

The major successes of the Phase 1 Work Plan included relationship building and coming together regularly with CBSA to openly discuss issues as they arise. Challenges have arisen with the changes in leadership, election seasons for both MCA and Canada that require a pause in our meetings, and, working through the pandemic.

#### **PHASE 2 WORK PLAN**

In 2022, CBSA welcomed a new president, Erin O'Gorman, who shares the intentions of her predecessor to ensure the border crossing experience continues to improve at the Cornwall-Akwesasne port. The Leadership Circle met to explore revising and updating the official Work Plan and a Phase 2 Work Plan was created.

#### **Phase 2 Working Circles**

- 1. Leadership Circle a continuation of Phase 1
- 2. Governance Circle continuation of Phase 1
- 3. Community Relations Working Circle a continuation of Phase 1
- 4. Cornwall Port of Entry Working Circle new
- 5. Dundee Port of Entry Working Circle new
- 6. Pre-Clearance Working Circle new

Note: With implementation of the Domestic Lane permanently, the Domestic Lane Working Circle has officially "closed." The Economic Development Working Circle was merged with the Community Relations Working Circle.

#### **NEW CIRCLE UPDATES**

#### 1. Dundee Port of Entry Working Circle

Historically, Akwesasne has not had regular and open communication with the Dundee port of entry. We do have land that is only acces-

sible by travelling through the Dundee border, and with the recent settlement of the Tsi Karistisere Dundee Land Claim, Akwesasne will be expanding its territory east, which will result in more regular use of the Dundee Port of Entry. Therefore, it is imperative that we begin building a relationship and working in collaboration. This circle has been meeting regularly and identifying their priorities which includes:

- Development of a remission order similar to the Cornwall Port of Entry's for tax and duty purposes
- Ensuring use of English language (not only French) and incorporation of Mohawk greetings
- Developing point of contacts for community announcements or community issues that arise

#### 2. Cornwall Port of Entry Working Circle

The Cornwall Port of Entry Working Circle consists of CBSA staff from the port itself, Chiefs Vanessa Adams, and Julie Phillips-Jacobs. With the Domestic Lane Pilot Project now in place permanently and that circle no longer needed, the Cornwall Port of Entry Working was created to work together with CBSA on issues and improvements that arise specific to the Cornwall port.

As with all circles, relationship building is part of this circle's purpose. As issues arise, we are able to discuss them quickly, often effectively, with mutual understanding and respect. When community members are having concerns, we are able to speak face to face with CBSA supervisors and staff who can help to improve the situation, and when issues arise that are at higher level of complexity, the leadership representatives will discuss that at their leaders meeting.

Some of the topics that we have had thorough and meaningful discussion on through the Cornwall Port of Entry circle include:

- Concerns of questioning domestic travelers
- Concerns of intrusive questioning of or about Akwesasne children
- Concerns of questioning or detaining of school buses
- Concerns of duty-free purchases made on Kawehno:ke
- The need for reporting exemptions for medical transportation/ staff
- Concerns of the new speed bumps causing physical damage to vehicles from bottoming out

With CBSA willing to hear our concerns and complaints with an open mind to improve the border crossing experience, many of these issues can be easily addressed, and when they can't be, they are taken up to the higher level of leadership. We encourage our community members to continue sharing concerns with us, or by submitting them on CBSA comments and complaints website for follow up.



The circle also includes positive activities including a youth art call out we have conducted to showcase youth artwork and Mohawk culture at the port. An Akwesasne artist is also being commissioned to in-

stall a more permanent display of Akwesasne culture.

Last spring, we were proud to coordinate school tours for the first time ever at CBSA. Students toured the facilities with their school and MCA staff chaperoning, and asked questions about the daily operations at the port and about working at CBSA. They also saw behind the scenes equipment and tools and met the CBSA drug detection dog named Blue. These visits are intended to take the mystery out of crossing through the port and to help our students feel more comfortable when crossing.

#### 3. Pre-Clearance Working Circle

The purpose of this circle is to collaboratively explore the possibility of a future CBSA port of entry on U.S. soil adjacent to the U.S. Customs in Rooseveltown/Massena, New York.

The need or interest in this had been identified in our earlier BCI sessions as both parties, MCA and CBSA agree that the current location of the port in Cornwall is not ideal. Its location has created the "mixedtraffic corridor" designation which adds complexities and grievances for Akwesasne residents especially. Relocating CBSA to the U.S. land in Rooseveltown would alleviate the burden that is experienced by anyone traveling to or from Kawehno:ke.

The relocation would eliminate the time-consuming duty to report when we are travelling only to the island and not the rest of Canada. It would also allow anyone to visit or travel to Cornwall Island from the rest of Canada without the burden of reporting at Customs, paying duty, etc.

Following the relocation of CBSA from Cornwall Island to Cornwall, Preclearance was identified by CBSA as a potential long-term solution. However, there were insurmountable obstacles at that time, including a lack of domestic and international authorities. On August 15, 2019, the Agreement on Land, Rail, Marine and Air Transport Preclearance was brought into force. The Preclearance Act, 2016 also came into force on that date and implements the terms of the Agreement into Canadian domestic law.

Given that the framework is now in place to implement Canadian preclearance, and the US has re-affirmed their on-going support, there is a desire to explore this as an option in the Cornwall POE context.

CBSA and MCA have now met regularly to explore the preclearance

option with a commitment to continue sharing information and updates and to develop a work plan for this project. CBSA has presented their work to date to Council, with an optimistic but realistic outlook. While they are committed to pursuing this pre-clearance option, there is a great amount of work to be done before it may be deemed possible, and the reality is that 1) this would take up to ten years to become a reality, and 2) there are many obstacles both within and outside of CBSA's control that could prevent such a project from moving forward. Some of these potential obstacles include the possibility that the US could choose to stop supporting such a project for any reason in the future. Financial considerations, legislative impacts and other government departments in Canada also need to be considered.

However, CBSA is committed to moving ahead with conducting the required research to determine how this project can move forward. They recently shared with MCA that they are creating a pilot pre-clearance project at a small border crossing to research and explore some of the logistical and technical aspects of a pre-clearance port of entry. A feasibility study is also underway to explore the land around the Rooseveltown area port of entry to determine where a CBSA port could be located exactly and what environmental factors exist.

We (MCA) are optimistic that with the interest and support of CBSA to pursue the Pre-Clearance port of entry, the possibility exists, and we will continue working together with good intentions. This working circle is not a guarantee that the pre-clearance port will come to fruition, and we want to be clear of this reality, but at this time we are satisfied and optimistic about the work that is underway.

#### CONCLUSION

We have a long history with CBSA and while issues arise, we will continue meeting and working together to find solutions that make the border crossing experience better, for all of us.

#### **February 5, 2024**






# **LAND CLAIMS UPDATE**

Please note that the following information is provided to the members of the community of Akwesasne, and is not to be provided to the public, media or any external entity. The information shared is without prejudice to any current and future land claims of the Mohawks of Akwesasne.

#### TSIKARISTISERE/DUNDEE SPECIFIC CLAIM

On April 29, 2015, the Government of Canada presented the Mohawks of Akwesasne with a global settlement offer in the amount of \$239,808,436.00 for the full and final settlement of the Dundee land claim.

- The Mohawks of Akwesasne will have the ability to purchase 18,282 additional acres of land returned to reserve status through the Additions to Reserve policy.
- Compensation from the Final Settlement Agreement in the amount of ~\$236M will be held in a new Trust
- Five Community education sessions on financial vehicle to hold the Dundee compensation were completed in June and July of 2023. Awaiting Council's directive to proceed.



#### THE 1796 TREATY (US) CLAIM

The 1796 Treaty Claim is for land set aside for Akwesasne in what St. Lawrence & Franklin Counties is now. The MCA, the Mohawk Nation Council of Chiefs, and the St. Regis Mohawk Tribe are litigants in a land claim filed in the U. S. Federal Court against the State of New York, the New York Power Authority, and others for lands, islands & resources belonging to the Mohawks of Akwesasne.

#### **SEAWAY CLAIM**

The Seaway Claim was filed in federal court in 1976, for damages to the Reserve related to construction of the Seaway in the 1950s.

- The MCA, INAC and Transport Canada were granted an abeyance in the court proceedings in order to negotiate toward a possible settlement of the claim.
- In 2008 a Past Grievance Final Settlement Agreement was signed between the Mohawks of Akwesasne and Ontario Power Generation after a community referendum. \$46 Million have been placed in Akwesasne Settlement Trust, and four (4) islands entered into the Additions to Reserve (ATR) Process.
- Offer from Canada for final settlement agreement for \$45M (global) received Dec 2017 regards to the Seaway.
- Draft final settlement agreement and referendum regulations (MCRs #2018/2019 #80; 2020/2021 #56;2020/2021 #196) evolved into community education & consultations in July 2023.
- Seaway Settlement referendum held in August 2023 did not pass. Awaiting Council's decision on how to proceed in 2024.

#### **NORTH SHORE CLAIM**

Filed in 2012, regarding the North Shore of the St. Law-rence River including 30 miles along the river and 18 miles inland. Canada rejected the claim due to lack of evidence regarding use and occupation.

- Further evidence is being gathered and will be submitted in the form of deeds, leases, and timber transactions.
- When resubmitted, an expedited review of the claim can be requested.

#### BAXTER AND BARNHART CLAIM

On April 6, 2016, Indigenous and Northern Affairs Canada (INAC) informed the Mohawk Council of Akwesasne that the Baxter and Barnhart Specific Claim has not been accepted for negotiation by Canada. It was not accepted based on technicalities. ISC claims that the U.S/Canada Boundary Commission, established after the Treaty of Ghent operated within its reasonable scope by deciding that the islands are within American territory. The islands were clearly in British territory prior to the 1822 Boundary Commission Re-

The claim will be resubmitted with pointed responses to ISC's reasons for not accepting it for negotiations.







- Vacuum heat registers and heat vents
- Check indoor and outdoor air vents are not blocked

Please remember: The dark grime around the window pane is just dirt. It can be cleaned with vinegar and elbow grease.
