**AKWESASNE DEMOLITION OF ADMINISTRATION BUILDING NO. 2**

The project is a complete demolition of the Mohawk Council of Akwesasne Administration Building No. 2, located at 92 Third Street in St. Regis, Quebec, on the Akwesasne Reserve. The building is three storeys with a gross floor area of approximately 721 square metres (approximately 240 square metres for each floor). The building is a steel framed structure with exterior load bearing concrete block walls and concrete foundations. The demolition will involve the removal of designated substances (including but not limited to asbestos and lead) from the building, the complete demolition of the building including foundations, removal of all asphalt on site and the removal and capping of existing services.

### **OPTIONAL SITE VISIT**

There will be an optional site visit held on Thursday, September 3, 2020 at 10:00am. Bidders will meet at 92 Third Street in St. Regis, Quebec, Akwesasne Reserve.

**Note: Bidders attending the site visit and only going to and from the site and not stopping in the United States, will not have to quarantine.**

1. Bidders are required to bring their passports as they will need to access the site through the Canada-USA border. Bidders should use the Cornwall Island / Rooseveltown border crossing.
2. Bidders must bring the following personal protective equipment: hard hat, safety boots, reflective vest, safety glasses and a non-medical mask/face covering.
3. Due to COVID-19, the following measures must be taken during the site visit:
  - a. Only one representative from each firm is allowed to attend
  - b. Bidders are required to wear a non-medical mask/face covering at all times outside of their vehicle
  - c. Bidders are requested to bring hand sanitizer for their own personal use.

### **CONSTRUCTION TIME**

The Contractor must perform and complete the Work within (18) weeks from the date of notification of acceptance of the offer.
