MASK MANDATE WITHIN MCA JURISDICTION STILL IN EFFECT

The Mohawk Council of Akwesasne's Department of Health (DOH) is reminding the community that the mask mandate is still in effect within the MCA jurisdiction. The Mohawk Council of Akwesasne follows the Eastern Ontario Health Unit's (EOHU) mandates, and masks are still required when in public areas, which includes MCA buildings and facilities.

Regardless of your vaccination status, masks are still required when in public settings, such as MCA office buildings and businesses in the northern por-

tion of Akwesasne. Social distancing of up to 6-feet is still being followed when in public as well. Please continue to adhere to the public health measures that have been put in place, as they were developed to keep our community safe.

MCA & SRMT UNITE TO SHARE URGENCY OF VACCINATION AMID RISKS OF DELTA VARIANT

(AUGUST 11)

The Mohawk Council of Akwesasne and Saint Regis Mohawk Tribe are jointly urging the community to receive the COVID-19 vaccination. New surges of cases worldwide caused by the highly contagious Delta variant are creating high risks to anyone who is unvaccinated, including young and healthy people. The Delta variant has been confirmed in Akwesasne.

“What we are learning is that individuals who may have previously been strong enough to fight COVID-19 off as a regular flu-like cold are now experiencing more serious illness and hospitalization due to the Delta variant’s strength,” said the Mohawk Council of Akwesasne. “We are emphatically advising all community members 12 and over to access the best defense there is against this disease – vaccination.”

The MCA and SRMT are working together to strategize on ways to help the community avoid a 4th wave of infection or deaths. It is the unanimous opinion of both Councils that vaccinations are safe, effective, and necessary in this pandemic.

“We need our community members to weigh facts against fears,” said the Saint Regis Mohawk Tribal Council. “We sincerely understand the emotions behind vaccine hesitation, but we can’t emphasize enough

that the benefits of vaccination far outweigh any risks, and that your chance of becoming seriously ill from COVID-19 is the reality.”

Both councils encourage the community to consider the risk to children under the age of 12 who cannot yet receive the vaccine, and also those who are unable to be vaccinated due to medical reasons. You can protect them while also protecting yourself.

Please make informed decisions based on facts and science; vaccinations work. It’s your future, your community, your culture and your children. Help us reach community immunity and make your vaccine appointment today. We truly are all in this together.

PLEASE FOLLOW SAFETY PRACTICES WHEN PARKING ON ROADS IN KANA:TAKON

The Mohawk Council of Akwesasne is reminding the community and visitors to be considerate of safety practices when parking on the streets in Kana:takon.

Residents have expressed concerns regarding unsafe parking, which creates difficulties when navigating the streets. Parking on the street near intersections should be avoided, as it creates a hazardous sight obstruction, obstructs walkways for children and adults walking in the district, and could create an unnecessary accident. Additionally, when cars are parked unsafely, it creates obstacles for Emergency Vehicles to maneuver through the roads. We understand that parking is limited in Kana:takon, but we must ensure that everyone can safely drive in the district. Community members are welcome to utilize Mohawk Council of Akwesasne parking lots, pending availability, after-hours and on weekends.

Please consider these safety tips when parking on roadways in Kana:takon:

- Do not park on a curve, hill or anywhere you do not

have a clear view in both directions.

- Do not park where you will block a sidewalk, crossing, or driveway.
- Do not park near an intersection, which can create sign obstructions for oncoming traffic.
- Ensure that your vehicle is pulled over in shoulder as far as possible to allow oncoming traffic to move through.
- Be considerate of the speed zones and whenever you are approaching a vehicle parked on the road, please slow down!
- Do not park within three metres (10 feet) of a fire hydrant.
- After parking, always turn off the ignition and lights, and remove the keys. Do not leave children or animals in vehicles.
- Before moving from a parked position, always signal and check for oncoming traffic, pulling out only when it is safe to do so.

COMMUNITY HEALTH PROGRAM PROVIDES UPDATE ON SCHOOL-REQUIRED VACCINES

The Mohawk Council of Akwesasne's Community Health Program offers vaccinations in accordance with the Publicly Funded Immunization Schedule for Ontario. Publicly funded vaccines are provided to eligible individuals free of charge.

Students that attend schools in the United States will require vaccinations that the Community Health Program cannot provide at their office without a prescription, which will have to be filled at the cost of the individual. If you are not sure whether your required vaccines are free at the Community Health Program office, please call 613-575-2341 ext. 3220.

Students requiring vaccines outside of the Ontario Publicly Funded Schedule will require a prescription from a healthcare provider, and be filled at the individual's expense.

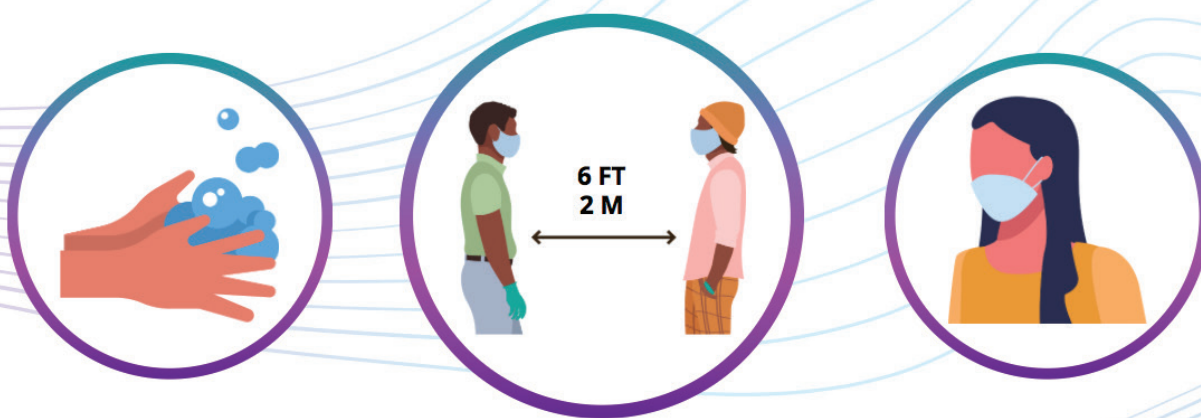
Prior to filling a vaccine prescription please ensure that

you have an appointment with the Community Health Vaccine Nurse, as walk-ins are not accepted.

For children attending school at the Ahkwesahsne Mohawk Board of Education (AMBE) schools, the School Based Immunization Program for Grade 7 and 8 students is deferred until further notice. We expect that this situation will change by mid-October.

It is advised that individuals call the St. Regis Mohawk Tribe Health Services to see if their child is eligible to receive the vaccinations that are required for entrance to schools in New York State.

Thank you for your understanding. Our goal is to vaccinate all children in a timely and safe manner in accordance with the Publicly Funded Immunization Schedule. If you have any questions or concerns, please call the Community Health Program at 613-575-2341.

INSPECTING YOUR HOME HEATING FUEL TANK

Home heating oil fuel tanks should be replaced if they are anywhere from 15-20 years old or show signs of leakage.

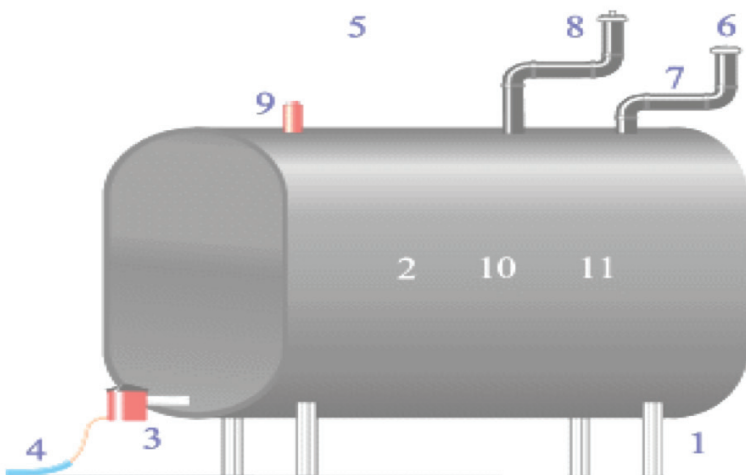
An aging tank is not only potentially harmful to the surrounding environment, but could prove costly and inconvenient if its contents escape from your tank. As a homeowner or landlord, you are legally responsible for these costs.

The good news is most oil tank problems can be avoided. Emergency Measures recommends the following:

1. Check for leaks before and after each delivery.
2. If you smell diesel or home heating fuel, immediately check your lines, tank and furnace for leaks.
3. Consider replacing oil tanks after 15 years of service. The price of a new tank is considerably less expensive than the cleanup.
4. Make sure all attachments are firmly secured.
5. Always fill your tank at the end of the heating season to help prevent rust caused by condensation inside the tank.

Answer These Questions!

Each question is represented by a number on the Fuel Tank image below.



1. Are the tank legs unstable or on a shaky foundation?
2. Are there any signs of rust, weeping, wet spots or dents on the tank?
3. Is the tank blackened at the low end, around the drain? (This may be an indication of water in the tank, and resultant corrosion inside the tank.)
4. Are there any drips or signs of leakage around the fuel line, filter or valves?
5. Is there danger of snow or ice falling on the tank?
6. Is the vent clogged or restricted because of snow, ice or insect nests? (Screened vents can help prevent insect nest problems.)
7. Is the vent whistle silent when the tank is being filled? (Ask the fuel delivery person.)
8. Are there signs of leakage or spills around the fill pipe or vent pipe?
9. Is the fuel-level gauge cracked, stuck or frozen? Are there signs of oil around it?
10. If mounted outdoors, is the tank rated for outdoor use?
11. What is the age of the tank? (Not usually indicated until after 1998.)

If you answered 'yes' to any of the questions above, call your local fuel service provider to arrange a detailed tank inspection today.

JULY 26, 2021

- The Program Manager for MCA Environment and representatives from Food Cyler presented to Council a proposed pilot project whereby members of Akwesasne will use the Food Cyler to help reduce waste.

- Council discussed the need to examine the placement of guard-rails in various locations in Akwesasne. Administration will follow up on existing considerations/studies and report back.
- A briefing was provided on concerns regarding flooding in various parts of Tsi Snaihne; administration will follow up with the department on the status of issuance of RFP for a water level/flood assessment.
- Council agreed that no Council meeting will take place next week in light of the civic holiday.
- A briefing was provided on the status of portfolios and the upcoming selection session.
- **MCR's passed:** Assignment of lease - Thompson Island, Assignment of lease - Hamilton Island, Approval of new lease - Ross Island, Approval of Fish Identification Nearshore Survey participation, Approval of funding application for Caring About Our Waste Initiative, Approval of signing officers for MCA BMO Canadian account.

AUGUST 9, 2021

- A briefing was provided regarding the past weekend meet and greet with the Deer Lake First Nation.
- Council agreed that the next regular General Meeting will take place on September 23, 2021. Agenda forthcoming.
- A request to include regular self-care exercises and a moment to reflect was requested and will be incorporated into Council's calendar.
- Council discussed the need to ensure the Council calendar is updated timely and that members of Council are sharing their calendars with staff.
- An update was provided on the annual evaluation for the Executive Director.
- Council discussed the decision to host District and General Meetings on ZOOM, Council determined that the decision to have them online will continuously be revisited.
- A briefing was provided on conflict-of-interest definition in the Akwesasne Financial Administration Law.
- Council discussed a concern with burned out streetlights, administration will follow up on the concern.
- A briefing was provided on community members challenges with vehicle registration in Quebec and having to pay taxes.
- **MCR's passed:** Approval of appointment of community members to Council of Elders; Approval of (3) Council Meeting minutes.

- Council discussed the need to develop a process and protocol for requesting administrative reports and follow up.
- A briefing was provided on a self-insurance initiative that was previously implemented for Council's consideration.
- Administration informed Council that revisions to the Good Standing Policy will be forthcoming to Council for consideration.
- A briefing was provided on a request for Council to consider reviewing and rescinding where appropriate outdated by-laws.
- Council discussed a request from a group of Akwesasne Residential School Survivors requesting assistance to attend a commemoration for Joey Commanda in Six Nations. Council agreed to provide financial support.
- A briefing was provided on the MCA's programs efforts to assist a homeless member, further follow up will be done on additional options.
- Council was briefed on the status of the lease reduction initiatives for Akwesasne lease holders, Council will discuss the extension or expiry of the initiatives next week.
- A request for the MCA on-call listing was requested and will be distributed to Council.
- Council received a briefing on a complaint and situation on a driveway construction on Akwesasne International Road.
- A request for a presentation from AMPS on their efforts to combat the sale and trafficking of fentanyl and other opioids will be made and will be scheduled.
- Council discussed the current intoxicants by-law and will further discuss during the Justice Department orientation.
- **MCR's passed:** Approval of authority to lethinsten:ha Family Wellness to grant occupancy licenses; Approval of Lease Ross Island; Approval of (2) assignment of lease Hamilton Island; Approval of assignment of lease Ross Island; Approval of agreement with Ontario for Gladue aftercare; Approval of application to Zero Emissions Vehicle Awareness Initiative and allocation of MCA contribution to the project; Approval of issuance of cannabis retail license; Approval of contribution agreement with Canada for the Fibre to the Home Project.

Monthly Notables:

- Memorial tree planting ceremony was done for late Chief Darryl Lazore. Darryl's family, friends and community members gathered at the St. Regis Recreation to honor Darryl and the achievements he had during his two term with the Mohawk Council of Akwesasne.
- All Council was sworn in at the A'nowara'ko:wa Arena under the pavilion. Due to COVID-19 restrictions attendance was limited but the ceremony was broadcasted on Facebook live.
- Special Needs strategic plan meeting. A carry over from pre-

vious Council. Various issues occurred and this was not done before the end of the term. Directors, Program Managers, community members and 3 Chiefs participated. Deadline for completion is the end of July.

- Ontario's Associate Minister of Mental Health and Addictions Michael Tibollo visit at Akwesasne Care center. Grand Chief accompanied the minister on a tour of Kawenoke. The border closure restricted a trip to Kana-takon and Tsi Sniahne. Maps were utilized to give a full understanding of our community. They then met more members of Council at the Akwesasne Care Center located in Cornwall. The topic of conversation was homelessness and addictions. The Minister commended Akwesasne on the Care center and pledged to offer support.
- Council met with members of the Deer Lake First Nation at Thompson Island.
- The Deer Lake is a community

of 1200 members, which was evacuated because of the smoke caused by the wildfires. 500 of their members are housed at Nav Can in Cornwall. There are many challenges for Deer Lake residents at Nav Can:

1. *Poor treatment*
 2. *Members come from a dry reserve, now having access again to alcohol has caused issues*
 3. *Not everyone gets along, and half of the community is in one place, requiring security*
 4. *Food quality is another big concern, they are accustomed to certain foods and are not allowed to bring food in.*
- The Federal Government is paying for everything, and the MCA EOC (Emergency Operation Centre) has been busy planning events and setting up things for the community to do off the premises. Weather unfortunately has also played a role in activities needing to be postponed. Our Council has committed to helping anyway that we can. Our

EOC manager will be on sight for the next 2 weeks as a Government Liaison to assist the Deer Lake Community at Nav Can

- Kanatakon District Chief's met at Admin 1 to discuss reporting requirements, office hours, communication strategies to reach Kanatakon district members.
- Nation Building Orientation. Information was provided on the self-government process and where it is at.
- 1. Introductions were given from the Entewatathawi team, legal team, and the Federal Negotiation team.

2. MCA continues to work on the agreement and have five 5 non-negotiable issues with Canada in which they were told that if they do not provide us with, then the agreement will not out to the community for acceptance, this included no taxation and no land expropriation.

3. Entewatathawi has also provided funding to conduct program reviews. An Akwesasne Justice review will be completed later this year and review of the Office of Vital Statistics has been recently completed.

- Council participated in our first

General Meeting via Zoom. Introductions were done as well as an overview of our ongoing orientation. Business from the floor and we passed an MCR for past General meeting minutes. This can be viewed on our website at www.akwesasne.ca.

- Communications set up a Facebook page for the Kanatakon District Chiefs to post updates and communicate with the Kanatakon District! It has been well received and I look forward to posting information and updates to our page.

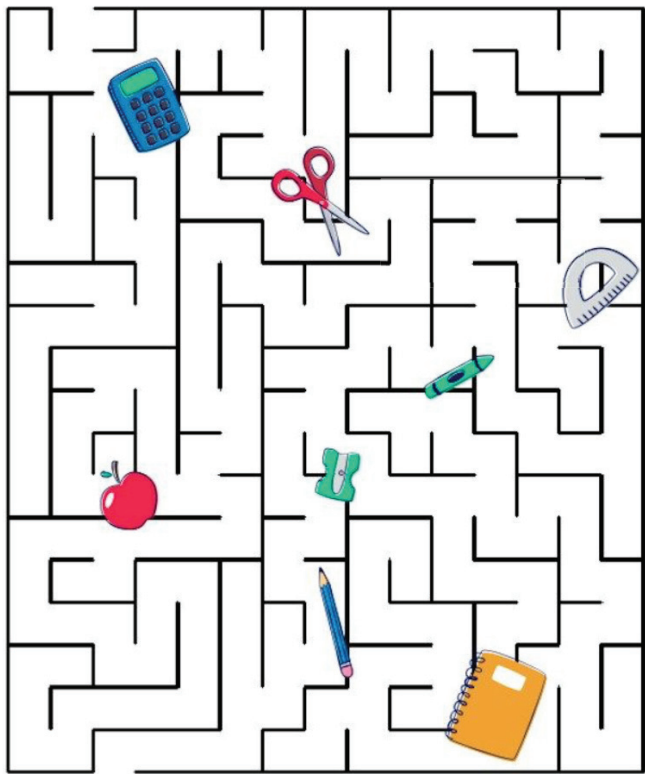

COVID-19 Vaccine Fact Sheet

Information provided by Health Canada

WHAT IS COVID-19?

COVID-19 is an infection caused by the coronavirus (SARS-CoV-2). It is passed from an infected person who coughs, breathes, sings, or talks (droplets from the mouth).

It is possible to have no symptoms and still spread the COVID-19 infection (asymptomatic).

HOW DOES THE COVID-19 VACCINES PROTECT AGAINST THE VIRUS?

The vaccine works by presenting your body with something that looks like the infection so that your immune system can learn how to produce its own natural protection.

This natural protection prevents infection if you come in contact with an individual who has COVID-19.

WHO CAN RECEIVE THE VACCINE?

The Pfizer BioNTech COVID-19 vaccine is approved for individuals 12 years of age and up.

The Moderna COVID-19 vaccine is approved for individuals 18 years of age and up.

A discussion with your primary healthcare provider can assist in the prevention of any complications from the vaccine.

HOW IS THE VACCINE ADMINISTERED?

The COVID-19 vaccine is administered via injection in two doses, given 21-28 days apart.

After receiving your first dose of the COVID-19 vaccine, you will be provided with a follow up appointment for your second dose.

WHAT ARE THE SIDE EFFECTS OF THE VACCINE?

The most commonly reported side effects are pain at the injection site, tiredness, headache, fatigue, chills, joint pain, and mild fever.

These side effects typically subside after 1-2 days after injection.

MY SIDE EFFECTS AREN'T GOING AWAY. NOW WHAT?

If your side effects haven't subsided after a few days, contact your healthcare provider.

Contact emergency services if you experience any adverse reactions such as:

- Hives
- Swelling of the face/mouth
- High fever
- Serious drowsiness
- Convulsions or seizure
- Numbness/"pins and needles"

What is COVID-19?

COVID-19 is an infection caused by the coronavirus (SARS-CoV-2), and is mainly passed from an infected person through coughing, sneezing, talking, breathing, or singing.

Cough, shortness of breath, fever, chills, body aches, tiredness, loss of taste or smell. An infected person can also have no symptoms at all (asymptomatic).

How does the vaccine protect me from COVID-19?

The vaccine works by presenting something to your body that looks like the infection, causing your body to produce its own natural protection. The natural protection helps prevent infection if you come in contact with an individual who has COVID-19.

Who can receive the COVID-19 vaccine?

The Pfizer BioNTech COVID-19 vaccine is currently approved for individuals 12 years of age and older. The vaccine is administered in two doses, 21-28 days apart.

What are the side effects of the vaccine?

The most common reported side effects are pain/swelling at the injection site, mild fever, chills, body aches, and tiredness. Some experience no side effects at all.

WHOLISTIC HEALTH & WELLNESS PROGRAM WARNS OF RISE IN FENTANYL OVERDOSES IN AND AROUND THE COMMUNITY

Due to the current and alarming increase in overdoses in the community and surrounding areas associated with the drug Fentanyl, the Tekanikonrahwa:kon (Wholistic Health & Wellness) Program is encouraging all members of our community to be aware.

Fentanyl is an illegal synthetic substance that has been associated with recent overdoses, often referred to as "Purple." Fentanyl is commonly found in smoking/inhaling vapor from transdermal "Patches". Fentanyl is sold illegally as a powder, made into sprays, in droppers, and is being mixed with other drugs, such as heroin, cocaine, methamphetamine, and MDMA. This is especially risky when people participating in drug use don't realize the drug might contain fentanyl as a cheap and dangerous additive. They might be taking stronger opioids than their bodies are used to and can be more likely to overdose. It takes very little for this potent drug to take effect, and with an extremely high risk of overdose and fatality, we urge you to be vigilant.

HOW CAN A FENTANYL OVERDOSE BE TREATED?

Many drug dealers mix fentanyl with other drugs like heroin, cocaine, MDMA, and methamphetamine to increase their profits, making it often difficult to know which drug is causing the overdose. Naloxone is a medicine that can treat a fentanyl overdose when given immediately when the overdose occurs. Naloxone works by rapidly binding to opioid receptors and blocking the effects of opioid drugs. Fentanyl is stronger than other opioid drugs, like morphine, and might require multiple doses of Naloxone. Naloxone is available as nasal sprays (NARCAN® and KLOXXADO®).

If you suspect someone has overdosed, the most important step to take is to call 911 or the Akwe-

sasne Mohawk Ambulance at 613-575-2000, and get the person overdosing immediate medical attention. Once medical personnel arrive, they will administer naloxone. If an individual has been trained in Naloxone (NARCAN) administration if they suspect an opioid drug is involved and NARCAN is available it can be given while emergency numbers are being engaged to help reverse an overdose until emergency personnel arrive on scene.

If you know someone who is using drugs, you yourself participate in drug use, or have a loved one engaging in substance use, it is wise to carry Naloxone and be vigilant of the increased amounts in and around our area.

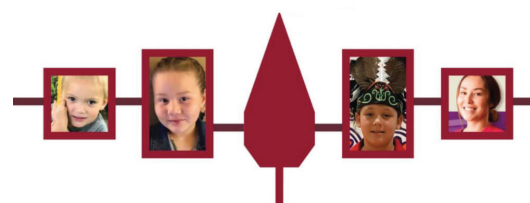

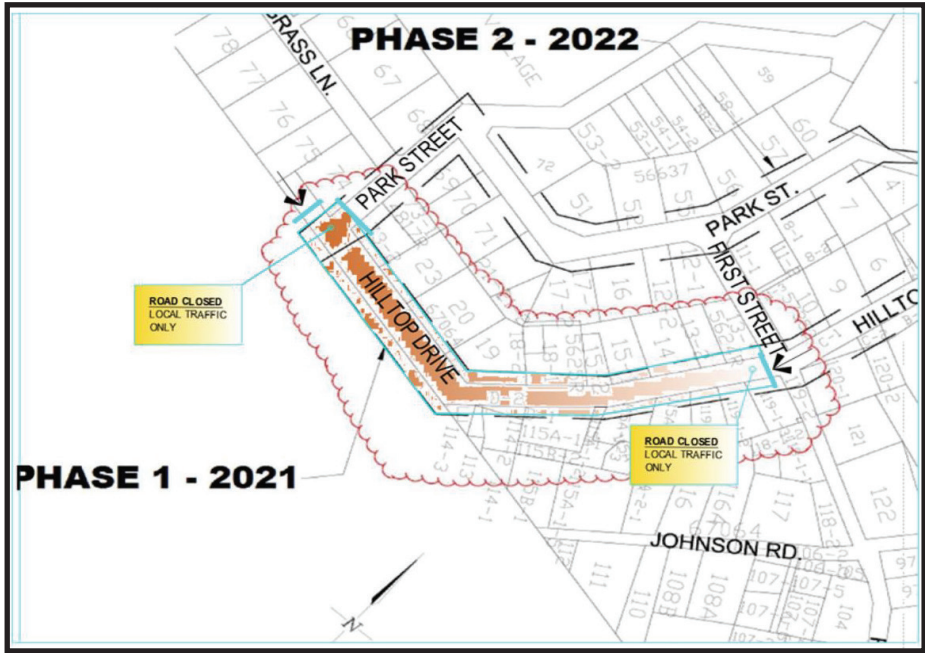

MCA DEPARTMENT OF INFRASTRUCTURE HOUSING & ENVIRONMENT (DIHE) – MAJOR CAPITAL PROJECTS:

Park Street & Hilltop Drive Reconstruction Project:

The Mohawk Council of Akwesasne Department of Infrastructure Housing & Environment (DIHE) will commence works to address deficiencies in sanitary sewer, storm sewer and ditches, and watermain, by the reconstruction of Hilltop Drive & Park Street within the District of Kana:takon (St. Regis). The MCA was notified by Indigenous Services Canada on August 11th, that the DIHE Project Approval Request was for \$2.8 million dollars in funding was successful which also signaled the DIHE’s ability to move forward with the project Tender award for construction.

Through Tender process, the MCA awarded the construction contract to Lazore’s construction.



The work plan will be done in two phases that includes sanitary sewer replacement, installation of proposed storm sewer, & complete road reconstruction. Hilltop Drive is part of the first phase that is 570 meters of reconstruction and Park Street is 420 meters that is part of the second phase of reconstruction.

To allow for traffic routing, Phase I, Hilltop Drive (south), will be done first as it is the less invasive work to the waterworks and will be reconstructed to support detour for Phase II which will be the full length of Park Street and the remaining length of Hilltop Drive (north) that will include the reconstruction of the water wastewater infrastructure along with the road reconstruction.

As part of this detour, the Department of Health is asking traffic going to the health facility to use the driveway entrance going toward the CKON radio building area and health facility parking lot and NOT the Akwesasne Ambulance area exit and parking.



Detour 1. at First Street & Hilltop Dr. intersection indicates to travel through to Park Street. Detour 2. Turn left onto Park Street and follow to Kanonhkwa'tsheri:io facility.

Phase 1, Hilltop Drive Road Reconstruction started on August 16th, and is planned to be completed by November 5th, 2021 with full restoration of residential yard entrances. The Phase II will start as early as possible in the year 2022 and is planned to be completed within the year 2022.

Road Assessments:

DIHE will be preparing a Request for Proposal (RFP) to hire a Consultant Engineer to perform a Road Traffic Feasibility Study within the Districts under the jurisdiction of the Mohawk Council of Akwesasne. The study will consider the current needs of the community in relation to traffic laws and safety, then provide recommendations for current roads need.

DIHE has received concern from District Members within the Village of Kana:takon indicating the difficulty with observing Stop signs and posted Speed signs due to vehicles being parked too close to the signs or corners. The concern is for the health and safety of pedestrians, cyclists, and motorists. Know that it is illegal to park within certain distances of Stop signs and it is a citable offense. Your consideration to respect the conditions related to road safety is appreciated.

DIHE has received numerous complaints of household waste/bulk waste being dumped illegally at the end of Wade Lafrance Memorial Road in Snye, Cherry Street in Kana:takon, and at the end of Tewesateni Road on Kawehno:ke. The Mohawk Council of Akwesasne through its Department of Infrastructure Housing and Environment spend roughly \$480,000 per year to provide waste management services for all the districts and that includes a regular household garbage pick-up.

Recycling — Tuesdays for all districts

As a prevention measure to illegal dumping at the end of Wade Lafrance Memorial Road, DIHE has installed a gated & locked fence. There will be a ditch installed and there is signage posted.

Please do not dump garbage illegally. We need community support to report anyone that may be seen doing illegal dumping. Our Environment and Conservation programs report that there are Waste materials that contain toxic substances, sharp objects, and household items that pose serious health and safety risks not only to humans but also to the soil and underground bodies of water.

AMPS PREPARES FOR BACK TO SCHOOL SAFETY

The Akwesasne Mohawk Police Service (AMPS) will be out patrolling school zones across the northern portion of Akwesasne in order to remind drivers school is back in session.

Officers will be paying close attention to school zones, speed limits, child restraint systems, school bus safety, aggressive driving and distracted driving concerns. In addition, officers will be conducting traffic control. Police are asking motorists to plan ahead and leave early for your commute to accommodate school bus stops and traffic backups.
