

**WHEREAS**, the COVID-19 Global Pandemic has created and exacerbated mental health illnesses and struggles for many communities including Akwesasne, and;

**WHEREAS**, the Community of Akwesasne has many families affected by the Indian Residential School systems whereby children were taken from their family and places in the residential schools for sometimes many years, and;

**WHEREAS**, the Tk'emlúps te Secwépemc First Nation recovered 215 children buried at the Kamloops Indian Residential School, subsequently resulting in many other First Nations recovering additional unmarked graves at various former residential school across Canada, and;

**WHEREAS**, the recent recoveries compounded by the impacts of the pandemic have affected many community members in varying ways resulting in individuals and families hurt, grieving and in need of healing, and;

**WHEREAS**, the Mohawk Council of Akwesasne (MCA) provides a number of supports to our members through our departments of health and community and social services who seek help with healing, and;

**WHEREAS**, the MCA is aware that within Akwesasne there are community based organization that provide healing support and services to community member and families, and;

**WHEREAS**, the Mohawk Council of Akwesasne acknowledges that the MCA organization is not always able to provide the preferred supports or methods of healing that community members are comfortable with and will access; and;

**WHEREAS**, the Mohawk Council of Akwesasne will create a community based healing fund that will be designed to support Akwesasne community based organization that provide support and healing to Akwesasneron who are in need of help, recovery and support to become healthy and whole, and;

**WHEREAS**, the Mohawk Council of Akwesasne will designate a review committee comprised of 3 District Chiefs and 3 Directors / Managers of the MCA who will be responsible for accepting, reviewing and recommending approval of funding submissions, and;

**WHEREAS**, a call for proposal will be conducted by Executive Services for a period of 21 days so that community-based organizations can submit funding proposals for consideration;

**FINALLY BE IT RESOLVED,** the call for proposal shall take place on October 25, 2021 for a twenty-one day period at which time the review committee will then meet to review and recommend funding awards to Council for acceptance;
