The exception to this is with the General Meeting Cancellation Protocol: MCR 2015/2016 - #260 *In the unfortunate circumstance where a community member passes in one of the three districts, the meeting will occur as regularly scheduled in the other two districts where the member did not reside. A moment of silence will also be taken in their memory.*

The General Meetings are an opportunity for Community Members to hear information from Council and assist Council with issues that affect the community.

The following General Meeting Rules were originally developed at a community General Meeting in July of 2006. The principles for 'General Meeting Rules' is based on respect for each other, and all attendees are expected to behave respectfully and professionally at all times.

### **General Meeting Rules:**

1. Meetings will start at 6:00 p.m. and proceed to a maximum of 8:00 p.m. at which point the community will be asked if they choose to continue past 8:00 p.m.
2. Personal issues will not be dealt with in a public forum/General Meetings. Personal items can be dealt with on an individual basis with Council Members (or by appointment through the Mohawk Government Office).
3. If you have questions or comments during the meeting – raise your hand and wait to be acknowledged by the Chairperson. The Chairperson will keep note of the order that community members indicate to be acknowledged.
4. Please keep the questions and comments relevant to the point of order within the agenda and be considerate of the time used.
5. A list will be made of issues you wish to address to Council and if the answer cannot be provided at the current meeting, the issue will be taken back to Council table for further discussion and follow-up.

# WEEK 1

- Weekly Council Meeting
  - Regular updates and discussions on current Council matters.
- Border Partners Meeting
  - Monthly meeting with the Tribe, Canada Border Services Agency (CBSA), and U.S. Customs and Border Protection to address ongoing border crossing issues.
  - Discussed the U.S. Customs' interest in replacing existing concrete barriers with a "shark teeth" system.
- Akweksko:wa Port Divestiture Committee Meeting
  - Reviewed strategic steps for advancing the development of the Port Lands in Cornwall.
- POM (Partnership OPG and MCA) Meeting
  - Continued progress on the Ontario Power Generation (OPG) Agreement.
  - Discussed setting specific targets for employment and contracting opportunities.
- Entewatatha:wi Portfolio Meeting
  - Collaborated on the Entewatatha:wi Self-Government Agreement.
  - Reviewed applicable federal laws and how they are integrated into the agreement.
- Meeting with MPP Nolan Quinn, Minister of Colleges and Universities
  - Discussed opportunities in economic development and post-secondary education.
  - Identified potential to attract international students due to high tariffs elsewhere, which may benefit Akwesasne applicants.
- Iroquois Caucus Webinar – Government Finances 101
  - Webinar led by Amy Lickers providing an overview of government finance processes.
- Governance Committee Meeting
  - Ongoing discussions related to governance matters.
- Executive Committee Meeting
  - Strategic updates and high-level decision-making.

This week focused on key discussions surrounding governance, infrastructure, and external relations. Notably, Council participated in meetings with Transport Canada and the Seaway International Bridge Corporation Limited, where longstanding concerns regarding lack of consultation were addressed. We discussed the tolls and looking for solutions to delay the increase on the toll cost which was unsuccessful. The Grand Chief emphasized the importance of maintaining strong due diligence and advancing community priorities.




Council continues to monitor the bridge and roadway maintenance agreements that impact the daily lives of residents in Kawehno:ke and broader Akwesasne.

Efforts were also made to review correspondence with federal departments and advocate for clear lines of accountability in future infrastructure planning.

  - Strategic planning session focused on border and tariff-related issues affecting the community.
- Meeting with Department of Infrastructure, Housing and Environment (DIHE)
  - Discussion on collaborative initiatives related to housing and environment for Akwesasne.
- Meeting with MP Larry Brock
  - Engaged with MP Brock, alongside the Chiefs of Ontario, to discuss First Nations priorities at the federal level.
- Meeting with Minister Cho
  - Explored the potential for a casino project in Cornwall, including discussions on feasibility and next steps.
- Class Action Lawsuit Presentation – Nathan Richards, Legal Counsel
  - Received a presentation regarding an active class action lawsuit, including discussion on AMPS (Akwesasne Mohawk Police Service).
- Ontario Trillium Foundation (OTF) Recognition Event
  - Participated in an event recognizing the OTF for awarding Akwesasne a four-year, \$500,000 grant in the summer of 2021 to support community initiatives.
- Governance Committee Meeting
  - Reviewed governance policies and upcoming initiatives.

Council continued internal deliberations on nation-to-nation governance matters. Discussions focused on expectations, deadlines, and formal recognition of representation of each party of the NYS Land Claims Settlement. Chiefs emphasized the importance of accountability and timely decision-making to move forward cohesively.




The internal discussion will shape how inclusivity and authority are shared across traditional and elected structures.

The goal is to build a shared path forward without compromising transparency or the roles each body plays in representing Akwesasne.

  - Attended the Throne Speech where the Lieutenant Governor addressed newly elected Members of Provincial Parliament and outlined the government's legislative agenda moving forward.
- Meeting with Minister Greg Rickford – Indigenous Affairs, Ontario
  - Engaged in a productive discussion focused on economic development opportunities and a shared commitment to collaboration.
- Meetings with Provincial Representatives
  - MP Eric Duncan – General engagement and relationship-building.
  - MPP Nolan Quinn – Continued dialogue on regional issues.
  - Solicitor General Michael Kerzner – Discussed matters related to public safety in Akwesasne and broader Indigenous communities.
  - MPP Stéphane Sarrazin – Introduced Akwesasne priorities and explored opportunities for cooperation.
- Leadership Committee Meeting
  - Nominated Grand Chief Joel Abram as the new representative for the Assembly of First Nations (AFN) Chiefs Committee on Economic Development and the Chiefs Committee on Cannabis.
  - Discussed proposed dates and planning for the upcoming Fall Chiefs Assembly.

Council focused on human resource development, including the interview and hiring process for a key administrative position. Discussions centered on candidate availability, equitable evaluation processes, and the importance of selecting a candidate who brings value and long-term dedication to the organization. Support was offered for drafting strong, relevant interview questions.



A flexible approach was taken to accommodate schedules and ensure an inclusive, community-minded hiring process.

These steps are part of a broader effort to improve capacity and ensure that the administrative structure supports Council's vision.

# WEEK 5

- FNMPC Conference
  - Made contact with Canada indigenous guarantee loan program
  - Made a connection with Export Development Canada
  - Met with Alto about the High Frequency Rail System
  - Key outcomes:
    - Initiated potential collaboration with Hydro-Québec via Kahnawà:ke leadership to enhance energy infrastructure in Akwesasne (QC sector).
    - Connected with Export Development Canada (EDC) to explore international trade opportunities using Cornwall's Port Lands.
    - Met with Ontario Lottery and Gaming (OLG) executives to discuss the feasibility of a casino resort in Cornwall.
  - Next steps:
    - Engage former Kahnawà:ke Grand Chief Kahsennenhawe Sky-Deer for Hydro-Québec introductions.
    - Follow up with EDC on trade logistics and partnerships.
    - Conduct market analysis for casino development.
    - Continue discussions with OLG on partnership and investment options.
- Executive Committee Meeting

Council engaged in international and intergovernmental reflection, with follow-up conversations on the IPEC 2024 meetings in Lima, Peru. The discussions reaffirmed the importance of international Indigenous diplomacy and highlighted the role of Akwesasne in advocating for economic sovereignty and trade partnerships abroad. Reports emphasized how Indigenous Peoples from different countries are building mutual support for global recognition.

The Grand Chief emphasized continued collaboration with Indigenous Services Canada to strengthen trade and economic frameworks led by First Nations.

Reflections also included how Akwesasne can apply global lessons locally, especially in trade capacity building and rights-based development.

**Monthly Notables:**

**Tsi Snaihne District Meeting:** May 12/25

There were nine people in attendance.

Topics: Community members would like to have focus meetings.

FNCFS Update: Community wants include early years (3-6) being paid from this program, sign language classes, feeding kids healthy foods at schools, teaching children healthy food choices, and promoting food sustainability. Invest in PSWs.

ABGC: funding cuts this year. Community members want quarterly reports for the funding given.

Mental Health: A Target for Youth and Young People. Possibly switch to quarterly health fairs.

How much does DOH spend on health fairs?

GPP needs to be updated. The Compensation Policy needs to be reviewed as volunteerism, and nothing in the policy for fluent speakers.

Community wants to input in our policies and define regulations, laws, codes etc. How many grievances/complaints has MCA received to date?

Border survey results that were done in 22/23.

There were a lot of administrative issues brought up which the Chiefs can only relate back to the A/Executive Director such as HR issues, Toxic work environment, Individuals in acting position for over three years when GPP saying three year maximum, grievances/appeals, how many people volunteer between 8 to 5, do better with recognition of service, meetings should be conducted on reserve and not in Cornwall, increase of aliens, where are the police? What are we doing about a dentist? Why did we have the budget and audit on the same night? Rescind the AFAL, remind Grand Chief how he addresses people. Why is are Police Commission updating its own charter?



**Council Meetings:** May 5, 12, 26/25

MCRs are presented and acted upon.

Presentation for May 5 is the lonkwaronkhaonhakeh Group. This group is asking for funding to continue to learn the Mohawk language. They don't want to lose what they have learned and want to continue to work with elders on different projects.

**Presentation from AMBE:** Org Chart.

Director of AMBE presented one addition to the org chart, and that is for an Associate Director for Tsi Snaihne School.

**Special General Meeting:** May 13/25

The presentation of the budget and audit was continued by the DFA.

Discussion and questions were asked about the Auditor, whether they were independent or at arm's length. This was brought up two years ago, and it's still the same auditor. An RFP will be going out for next year's audit.

**Executive Committee:** May 14/25

The Committee met with Pathways to go through the applicants who applied for the Executive Director position. The next step is interviews for five applicants.

May 29/25: Interviews started.

**Other Meetings:** May 6/25

Cornwall Community Hospital with Vice President, Chief Nursing Officer, President, CEO, CCH, Indigenous Navigator. Discussed different scenarios that have happened, and the Complaint Process was discussed. The role of the Indigenous Navigator is to advocate for community members who are in the hospital.

There is an FN person on the Board of the CCH.

**Border Partners Mtg:** May 6/25

CBSA reported not much traffic going through the border. New recruits are expected at the beginning of June. NY Border: Tire shredder has been installed. Traffic seems to be all local.

**Quebec Protocol:** May 7/25

Discussed the agreement that will expire in December.

**FNCFS: Directors-Chiefs Mtg.:** May 7/25

Discussed how to disburse funding from the FNCFS. Some of the ideas were housing for renovations, fixing recreation centres, sustainability checks for all Northern Portion, technology for children in care and out of care, and playground equipment.

**Residency Law Amendments:** May 7/25

Continued work on the amendments to the residency law.

**Strategic Plan Meeting:** May 21/25

Directors and Chiefs met to discuss five-year and two-year goals, lobbying needs, shovel-ready projects, and Economic Development.

**TsiSnaihne Recreation Meeting:** May 27/25

Met with Snye Rec Reps and reported on what needs to be worked on at the TsiSnaihne Rec. With the funding given by the FNCFS all the work they want to do aligns with the criteria.

**OPG Meeting:** May 20/25

Met with OPG representatives and Ec. Development Director. Discussions on Arena expansion, updates were given on Thompson Island, procurements, and an ask for a wire to run from the Island to OPG for fiber. MCA and OPG gave updates on what is being worked on. OPG also gave an update on Employment/Contracting, Corporate Citizenship Program, Capacity Building, Reconciliation Action Plan, OPG outreach on awareness, and visitor centre usage.

**Government Secretariat:** May 13/25

Updates were given by Chiefs, Executive Administration, ARRO, Nation Building, Mohawk Government, and Grand Chiefs EA.

**Nation Building:** conflicting schedules, did not attend.

**DCSS Meeting:** May 27/25

The A/Directors and Legal for DCSS presented the DCSS policy review for ACFS. Questions were asked at the end of the presentation. For example, does DCSS have a working agreement with SRMT? Why is this policy Ontario-based when two-thirds of the reserve is in Quebec? Will the policy be on MCA website? DCSS Legal is also working on the Enietiswanonha Law.

**DIHE Meeting:** May 27/25

The Director went through the capital projects and what is shovel-ready. Discussions were on the waterline hookups. The Director and Housing Manager went through a list of projects they would like to use the funding for from the FNCFS. The Hemlock project and Wade Lafrance project are both ready to start.

**YECL Committee:** May 6/25

Discussed SRMT Strat Plan and the options for students to go to School. Language Symposium. Possibly host a symposium in Akwesasne. Topics to discuss are the gaps, where people are as 1<sup>st</sup> and 2<sup>nd</sup> language speakers. We also discussed elder callouts to sit on this committee. Working on MCR Youth Council terms of reference and charter. We need to give honorariums to the youth and elders. Need to find out the allocation for the YECL.

**Language Presentation:** May 20/25

A presentation was given by a community member on a Holistic Approach to Language Revitalization. What is needed immediately is adult immersion, childcare immersion, and language building.

**OVS Committee Meeting:** May 16/25

A discussion on the complaint by a tenant on Hamilton Island. Other discussions include CIS popups, SCIS MRZ popups, Backlog of Membership applications, and Complaints being dealt with in regard to wills.

**Housing:** May 28/25

The director stated she presented a business case for a position and has been held back. Chiefs will look into this. New Builds, renovation loans, and updates were given.

**Works in Progress: Ongoing**

1. Quebec Protocol Agreement: Renegotiating the agreement with Quebec. Reviewing for finalization.
2. YECL (Youth Elders Culture Language): working on terms of reference and reviewing the Charter.
3. Executive Director position: ongoing.

#### April 28<sup>th</sup> – May 2<sup>nd</sup>

I started the week out with the weekly council meeting and caught up on reports. I travelled to Oshweken, ON to attend a conference called 'To Find Our Wampum All White: Responses to Grand General Council of 1858'. The conference provided information on leaders of various Onkwehonwe communities throughout Ontario and included the Mohawk Communities at Akwesasne, Kahnawake and Kanesatake but was mainly focused on the communities around the Great Lakes. The focus was to show how and why wampum belts were used between the Nations in Ontario as well as with the British and American peoples. I will review the documentation I received from the conference and review with ARRO.

#### May 5<sup>th</sup> – May 9<sup>th</sup>



After the weekly council meeting, I travelled to Saint Michel des Saints Qc to attend a conference titled 'Circle of Indigenous Protected Areas' hosted by the Atikamekw Nation of Manawan and the First Nation of Quebec and Labrador Sustainable Development Institute (FNQLSDI). In 2021, the FNQLSDI began talking with Onkwehonwe communities in Quebec and Labrador to look at the possibility of creating protected environmental habitats throughout their territories.



Plans were developed by a few communities and one in Manawan, QC was chosen to start. The community has over 10,000 square hectares now held as protected areas throughout their territory. This creates areas for wildlife and gives the community the ability to conduct Duty to Consult and Accommodate talks with any potential resource developer wishing to complete projects in the area. Other communities have begun the process to create their own protected areas and are at various stages of development. This could be something of interest to Akwesasne.

### **Akwesasne Rights and Research Office**

- Attended meetings hosted by Parks Canada, with other First Nations to discuss the reburials that need to occur.
- Discussed the Seaway Court case and what MCA will do next in order find a resolution to the court case.
- Updated on the progress of an Enbridge project in the Glendale ON, area.

### **Public Safety**

- Attended Police Commission meeting and provided issues that were brought up by community members.
- AMPS updated council on equipment needs.
- Funding for additional Compliance Officers may be available.
- Met with the Public Safety Minister Mr. Gary Anandasagaree (pictures below).

### **Entewatathá:wi/Nation Building**

- Entewatathá:wi was conducting a survey to better understand community awareness, understanding, and thoughts on the Entewatathá:wi Self-Government Agreement (ESGA) and had a great turnout. More information sessions will be held throughout the year

## **Committees:**

### **Youth, Elders, Culture and Language**

- I attended my first meeting, and the committee was provided a presentation by a community member who would like to enhance local language initiatives.

### **Iroquois Caucus**

- Reviewed letters being sent to Prime Minister Mark Carney from the IC.

### **Hydro Quebec**

- Working on the distribution of 75 batteries

## Monthly Notables:

- Met with Indigenous Leadership Initiative - Guardians Program to discuss what the programs and could help with regarding environmental protection, conservation and resource development projects. These programs help establish a group of land guardians who would visit projects within the Akwesasne territory to ensure they are compliant with environmental standards.
- Obtaining estimates on nuisance animal kennel and budget.
- Met with Public Safety Minister Mr. Gary Asandagaree. We provided him with a tour of Akwesasne and highlighted the Public Safety needs of Akwesasne including the Fire Departments, Police Department and Ambulance Services.

## Tsi Snaihne District Meeting

### Topics:

#### Presentation to Community Members- Non-Insured

- Tessa Jocko, A/Health Director & Melanie Gibson, Program Manager for Non-Insured
- Discussed elder retirement benefits and the potential need for a senior benefits committee and supplemental insurance.
- Reviewed issues with non-insured health benefits, appeal processes, and prescription coverage gaps.
- Raised concern about lack of pharmacy consultant and asked for clarity on who manages denied claims and appeals.
- Recommended quarterly updates and intro videos from associate directors to help the community understand who does what at MCA.
- Community questioned why budgets are MCR'd before community input, and called for more transparency in spending.
- Requested a full Special Needs presentation with service stats by age and year.
- Noted short notice given about the dentist's departure, suggesting better communication.
- Recommended Chiefs provide their own monthly updates separate from Onkwetake to allow space for MCA program updates.
- Flagged community concerns around cross-border issues, including:
  - Impact on child tax and income tax
  - Concerns about U.S. tuition rates and FAFSA filing
  - Status of the Haudenosaunee Promise Scholarship for Canadian-born citizens.

# Monthly Notables:

## **April 12<sup>th</sup>- YECL Committee Meeting**

- Met with Language group to discuss language revitalization.
  - Focus was on how the northern portion of Akwesasne can contribute to Kaniehkaha learning at A:se Tsi Tewa:ton.
  - Discussed ways to work together to revitalize language and culture across the community.
  - Some members suggested extending A:se Tsi Tewa:ton program to three (3) years for deeper learning.

  - The discussion focused on improving communication, reducing emergency room wait times, access to patient records, and supporting community members navigating hospital care. Topics such as cultural safety, patient advocacy, and the inclusion of Akwesasronon youth and Elders in hospital advisory councils were also raised.
  - Both MCA and CCH expressed interest in hosting future wellness events and health education sessions, and meetings will now take place quarterly to keep momentum going.

## Border Partners Meeting

- Council participated in a Zoom meeting with Canada Border Services Agency (CBSA), Saint Regis Mohawk Tribe (SRMT), and Massena Port officials to share updates and strengthen coordination on cross-border matters.
  - Key Updates:
    - CBSA
      - Island Border Hours: Open daily from 7 a.m. to 11 p.m. CBSA confirmed ambulance access is always available.
      - CARM Commercial Program: Launch expected around May 20–22. No major delays expected at the local port, but national delays may occur. Our port can hold 10–12 trucks if needed.
      - Commercial Lane: Open Monday to Friday; weekends by request.
      - License Plate Reader Upgrades: Begin June 16—one lane affected per day, but four lanes (including the commercial lane) will remain available. Public messaging will be shared when the island lane changes.
      - Summer Planning: CBSA is increasing staff with 3 new recruits and is fully staffed for lacrosse season and summer events.
    - Massena Port Update:
      - Bob Dwyer is retiring at the end of the month. Tracy Casey remains the tribal liaison. The new tire shredder pilot is in place for wrong-way drivers only.
      - Creation of Records (Jay Treaty): Volume of requests is high, but Tracy reported it is being managed locally and nationally.

*This monthly report is provided as part of Council's aim towards providing a transparent and efficient governing system, which will also provide information to members of the community on updates of Mohawk Government, Portfolios, and Monthly Activities.*

#### **Here's a recap of notable events:**

- **May 1<sup>st</sup>** – On May 1st, I participated in welcoming the University of Ottawa's Cohort 18, who are enrolled in the Public Sector Leadership and Governance Program. This cohort consisted of 39 students from various departments across the Government of Canada. The Acting Executive Director provided opening remarks, followed by a Council Overview delivered by Chief Cindy Francis-Mitchell. Chief Teresa Oakes and I assisted with the Q&A portion, responding to inquiries from the students. Program managers from the Akwesasne Rights and Research Office and the Nation Building Program each provided overviews of their respective departments. The Justice Director and the Court Administrator also presented on Section 107 of the Indian Act, couples property law, other community laws, and the Akwesasne Court.
- **May 6<sup>th</sup>** - I participated in an introductory meeting with Jeanette Despatie (President and CEO), Kelly Shawn (VP of Patient Services and Chief Nursing Officer), and April White (Indigenous Patient Experience Navigator) from Cornwall Community Hospital (CCH). Key discussion topics included the role and accessibility of the Indigenous Patient Navigator at CCH, hospital wait times, and the function of the hospital's Patient and Family Advisory Board/Council. The team also shared a call for youth representatives to join the advisory board. Additionally, we discussed the importance of ensuring the MyChart patient portal becomes accessible to those with RAMQ coverage.



- **May 7<sup>th</sup>** - I attended a meeting with Directors and Program Managers to discuss the First Nations Child and Family Services (FNCFS) program, focusing on prevention, early intervention, and legislated protection services. The conversation centered on implementing the least disruptive measures to support children at risk of harm. This brainstorming session aimed to identify initiatives that align with the best interests of children, youth, and families, particularly in the areas of cultural and language revitalization, wellness support, and community-based resources. The goal is to ensure that the FNCFS prevention funding is used effectively to meet the immediate and long-term needs of our community.
- **May 21<sup>st</sup>**- I participated in a comprehensive strategic planning session alongside fellow Council of Chiefs, Executive Directors, and key staff members from the Mohawk Government. The session focused on aligning our collective leadership priorities with the operational vision, mission, and program goals across all departments.

**Key Outcomes:**

1. Identified Council's core priorities for governance over the next two years.
  2. Strengthened alignment between political direction and departmental work plans.
  3. Initiated discussions to ensure that all programs and services are moving in a unified direction that reflects community needs and strategic aspirations.
  4. Emphasized the importance of cross-portfolio collaboration to drive measurable impact and accountability.
- **May 27<sup>th</sup>**- Participated in a meeting with the Associate Director and legal counsel from Akwesasne Child and Family Services (ACFS), delivered a presentation on the ongoing revisions to their operational policies. The updates emphasize culturally grounded approaches rooted in Haudenosaunee teachings, Akwesasne perspectives, and a commitment to supporting the realization of inherent jurisdiction.

## **Portfolio Meetings**

### **Public Safety Portfolio**

- Attended the Police Commission monthly meeting, where we discussed the kids for fishing tournament had a great turnout of 50 kids.
- During the summer months, compliance will have a modified work schedule for the officers to be on the water with AMPS officers.

- The acting chief of police will be attending the Calgary Indigenous Police Forum on June 4th and 5th.

**Ahkwasasne Mohawk Board of Education Portfolio:** Attended the AMBE Board of Trustees meeting on May 20th, where the Chief Electoral Officer presented on the upcoming Board of Trustees election and advance polling procedures.

- A 15-minute public question period was held; however, there was no community participation.
- Two policies were reviewed and revised: *Preservation of Akwesasro:non Culture and Kanien'kehá:ka Language and Communications for Student Progress and Synergy*
- Upcoming cultural celebrations at the A'nowara'ko:wa Arena: May 22 for grades K3 to 3, and May 29 for grades 4 to 8.
- AMS and Tsi Snaihne School Student Council members will be holding a meet-and-greet to establish their goals for the upcoming school year.

### **Government Secretariat Portfolio Meeting:**

- Initiated discussions to update the Quebec Protocol Agreement by addressing emerging inter-provincial issues. Moving forward, we will integrate principles from UNDRIP, findings from the MCA Leakage Study, and priorities outlined in the MCA Strategic Plan to strengthen the agreement.

**Kana:takon District Meeting:** Four community members were present, community members present at District meeting said they would prefer quarterly district meeting and continue with monthly General meetings, would like to see quarterly updates on finances, questions on when road repairs will commence on Sweet Grass Lane, Johnson rd and 3<sup>rd</sup> St.

**Justice:** The Justice Departments Strategic plan continues to be worked on with Blackbird strategies, departments statistics will be available next month, ARAP will take on the snowsuit drive this coming winter season, Family Support Worker position needs to be filled. New oversight committee member, from the Snye district was sworn in. Terms of reference edits are almost complete and being reviewed by legal and then will go to council for approval. The Akwesasne Community Justice Program is set to do a presentation on Gladue Reports at an upcoming General Meeting.

A Gladue report is a specialized type of pre-sentencing or parole report used in the Canadian criminal justice system. It is named after the Supreme Court of Canada's decision in *R v Gladue* (1999), which recognized that Indigenous offenders may face unique circumstances that affect their involvement in crime and their rehabilitation.

The report is designed to provide the court with context regarding an Indigenous offender's background, including factors like historical trauma, systemic discrimination, intergenerational impacts of colonialism, residential schools, substance abuse, and socio-economic hardships that may have contributed to their criminal behavior.

Gladue reports aim to ensure that Indigenous offenders are treated fairly and that their unique circumstances are considered in the sentencing process. The purpose is to promote restorative justice, healing, and rehabilitation, rather than simply focusing on punitive measures.

The reports are usually written by a trained Gladue writer, often someone familiar with Indigenous cultures and issues. They can also recommend culturally appropriate alternatives to traditional sentencing, like community-based programs or restorative justice approaches, that may better support the offender's rehabilitation.

**Health:** Ambulance will be transitioning to Health Department, the patient navigator will soon have an office space at the Ormstown Hospital, the patient navigator position has been very well received by community and is proving to be a much needed position in the community. Health Fair took place at the Snye Recreation center on May 22.

**Public Safety:** Compliance will be working different hours to accommodate the summer months and will be on the river patrolling, Kids for fishing was done and was a successful event. The Chief of Police will be attending a Conference in Calgary June 3 and 4.

**DCSS:** Jordans Principle will be moving under DCSS, Akwesasne Family Wellness Program is currently having repairs done, the program manager flex's her time to accommodate the 24-hour facility, Courtney Skidders gave portfolio a fantastic presentation on a Indigenous Suicide Prevention Conference that she attended and how this would be a great opportunity for some of our local youth to attend an upcoming conference in New Zealand in 2026 for ages 14 and up. Babysitting and home alone courses will be upcoming, Too Good for Violence program are currently taking place in the schools, ACFS is also working with AMPS to get Community Watch going. Kids for fishing for children with Special Needs will also be taking place this Summer.

The first nations child and family services Jordans Principle settlement is officially open for claims as of March 10, 2025. The Federal Court approved the First Nations Child and Family Services and Jordan's Principle Settlement Agreement on October 24, 2023. This agreement aims to provide compensation to individuals harmed by the discriminatory underfunding of the First Nations Child and Family Services Program and those impacted by the federal government's restrictive interpretation of Jordan's Principle. The \$23.34 billion settlement follows compensation directives from the Canadian Human Rights Tribunal in 2019, which investigated systemic discrimination against First Nations children and families. They are ongoing community sessions for those needing assistance.

### Monthly Notables:

- Attended the General meeting for the Month of April.
- Participated in the Council meeting on Monday. Agenda items consist of Council invitations/meeting lists for the week for all Council. MCRs, discussion items and a presentation on the Nutfield Tract Update/Enbridge by ARRO and a representative from Enbridge.
- Participated in the Property Acquisition Team(PAT) meeting. The Team reviewed the Terms of Reference for these meetings. An invitation for a property was presented and a letter will be sent to the Owner for the PAT team to review and meet on. A few other properties were mentioned in the meeting and letters were suggested to be drafted for the Team to look at as well.
- Participated in the Contributions Repayable with the DFA. A list of funding was identified that had to be sent back due to no one in those positions to fulfill the duties and carry out responsibilities to ensure that the funds will get spent on programing in the Departments.
- Participated in the Health Advisory Board. Survey results were read on the needs that the Community wanted. Identified were weekend clinics, decrease wait times to see a Doctor etc.
- Participated in Council Meeting where MCR's, discussion items and a presentation from a group of community members submitted a proposal to continue a Mohawk Language journey and strengthen each other to continue with our language initiatives.
- Participated in the Border Meeting with the SRMT, US Customs, CBSA. The domestic lane is open from 7 am to 11 pm daily. There was a note that the CARM (CBSA Assessment and Revenue Management). This is for Transport Trucks. The CBSA assesses and collects duties and taxes on commercial goods imported into Canada using the CBSA port of entry. Commercial drivers are asked to sign up for this on their website. This will make their transition into Canada easier to prevent delays and impacts in transit. The CBSA can accommodate 20 trucks on the backside of the building. During the weekends, the truck lane is not open, and this may create congestion at the Customs. The license plate

reader replacement project will begin due to the need of upgrades to the system. One lane per day will be impacted by the upgrades. At the end of June, the CBSA will have three (3) new recruits. US Customs updates consist of the Emergency Pilot project for the Spikes on vehicles for Port Runners. The pilot will be for a 90-day period. If it is successful, they will begin to use this for the area where the Community members have to travel around all the barriers leaving the US Customs. There is a 6% decrease in traffic going to the US. This is mostly because of Canadians wanting to shop in the US and the impact of the Tariffs. The Green card issue was talked about and they informed us that Community members don't need to apply to the creation of records.

- Participated in the Political Protocol Agreement Session. Currently the Protocol agreement period was over in December of 2024. There are areas that may or may not be needed for the agreement between the Province of Quebec and Akwesasne, but the Departments of MCA will need to input into the document what will stay or be added. Akwesasne has a grace period of one year to agree on the terms that will be beneficial to Akwesasne.
- Participated in the First Nation Child and Family Service (FNCFS) meeting with available Council members and Directors. Council is looking at ways to bring the funding out to the community and help families. There was much discussion prior to meeting on zoom with a lawyer on what we can do with the FNCFS funds. Food sustainability was one of the ways that will be able to help out many families in Akwesasne due to the cost of food. A creation of a Parks and Recreation Department has been on asked about by community members for a while. The funding will be able to go towards this initiative and also looking at prevention services to meet the needs of Children as well as wellbeing of children and families. Housing issues or lack of was discussed, and many questions were raised about what is acceptable and what is not acceptable on use of the funds.
- Participated in the governance meeting where we did a line by line of the Council Meeting procedure regulations to be consistent with Laws and other regulations all related to Council. Ended at the beginning of section 9.
- Participated in Council Meeting where MCRS, discussion items and a presentation from AMBE on the Akwesasne Education Agreement and the addition to AMBE Org chart for two (2) Associate Principles positions in the schools.
- Participated in the Kana:takon District Meeting. Updates were provided on giving community members additional money in the month of June for food security initiative. Talked about donations on funerals and what funding is available to families. Donations from MCA donation request and Community support moneys can be accessed. On the Indigenous Services Canada (ISC) website it says to non-income assisted recipients who will qualify. Google: Indigenous Services Canada funeral assistance. An issue with the Akwesasne Mohawk Police Services (AMPS) boathouse parking is getting out of hand. The vehicles are taking over the area of road being accessed and the elders are noticing much more traffic in the area of the driveway towards the back of the building. They are parking on the lawn. The boathouse was only to be used to place the boat into the water and house the boat but not have the whole area taken over by AMPS. The district talked about having the beginning of the General meeting allocated specifically for elders who have concerns. It is very difficult for elders to sit a couple of hours and try to get a question in.
- Participated in the Government Secretariat meeting. All members did updates. This was my first meeting that I participated in since changing my portfolio from Environment to

Gov Sec. An update was provided that the ATIP policy is being updated, Duty to Consult position is being worked on, Nation Buildings survey resulted in 503 community members participating.

- Participated in the MCA Special General meeting to complete the Budget and Audit for the Community members held at AMS on Kawehno:ke.
- Participated in the Department of Health (DOH) Portfolio meeting. The Ambulance Program is being transferred back to DOH. Non insured is in need of software for data collections etc. and is on their list for purchasing due to the need of tracking of information. Dental space is being discussed. Health Fair is coming up in the district of Tsi Snaihne.
- Participated in the Akwesasne First Nations Extended Producer responsibility ERP Blue box meeting. This meeting was held on zoom with Circular Material. This is going to be the company we may have an agreement with to accept our recyclable materials that get picked up weekly. After meeting with them they will come back with terms and conditions that we will have to negotiate.
- Participated in the Environment Portfolio meeting.

### **Information from Environment meeting:**

**Bill 5** - Environment and ARRO are drafting an opposition letter as it removes environmental protections and requirements for archeological reviews. Flood Mitigation – Beaver trapping initiative has ended and staff would like to continue to encourage cultural stewardship as a beaver control instead of mass removal which is part an overall land planning strategy. Staff, along with Emergency Operations, has applied for further funding to continue this initiative. She has also attended a meeting with South Nation Conservation staff for to learn more about the modelling and process planning purposes. They identified opportunities to shadow SNCA staff as they undergo the development of SNCA floodplain mapping including – data collection, mapping, etc. SNCA is submitting a grant which will include a training aspect which will be offered to MCA.

**Aquatics** - are preparing for the upcoming field season including bringing in returning 5 summer students. FINS work will start the first week of June with a goal to survey a minimum of 20 properties. Staff would like to work towards developing a "Shoreline Health Report Cards" to provide to landowners whose properties we survey in Akwesasne. There will be a strong focus this year on capacity building with the newly acquired drone

Water and soil samples will be collected this summer to provide the data needed to plan initiatives to reduce eutrophication (harmful algal blooms).

Turtle surveys began this week to locate nests and install protectors where necessary. MCA's Incubator is prepped and ready to house eggs found in precarious locations to help boost the populations (very low success rate for eggs in nature due to predation and road mortality, 90% success rate with use of incubator. Last year MCA incubated 99 eggs.

**Waste Management** – Staff will be submitting an MCR to approve HGC as an interim receiver of our recycling materials. Meeting with Circular Materials was today and went well. We will need to negotiate with Circular Materials to include Quebec portions of the territory. If Quebec is not

included, costs can still be paid by ISC but will put an extra administrative burden on the contractor and waste coordinator.

Environment met with Holly McCumber from the Kahnawake Waste Program. Holly wants to assist MCA to start up a composting facility. A site would be needed to implement this. Perhaps composting and waste transfer activities could be on the same site.

**Terrestrial** – Staff has completed the Black Ash Stewardship project and produced a final report. Grant to continue this work has been requested and we are waiting for the response but I have been advised it likely won't be announced until after the federal budget is tabled.

We have secured funding for two summer students through Watersheds Canada. We'll bring these individuals on to support Staff in forestry work and terrestrial aspects of the RAP such as agricultural soil sampling.

A grant to study the eastern wolf has been approved. This will go to Council in an MCR to accept these funds.

Remedial Action Plan – RFP for a Biocultural Working group has been graded and a successful candidate has been chosen, this will be sent for MCR shortly.

Current RAP Issues to be addressed.

1. Do we accept and endorse the revised BUI 1 Delisting Criteria?
2. Do you provide permission/endorsement for MCA to enter a 60-day comment period to garner feedback on whether or not BUI #4 - Fish Tumours and Other Deformities should be re-designated from the status: "Requires Further" to "Not Impaired". Council supports number 2 to go to a 60-day comment period.

St. Lawrence Regional Impact Assessment – Environmental Assessment Officers taking on this project and they will be attending the Indigenous Centre for Cumulative

Effects National Conference this month to gain understanding the Impact Assessment. Terms of Reference will need to be endorsed through an MCR for further financial support on this project. Next steps are to begin planning the restoration activities we'd like to see undertaken in this area. Key issues identified are erosion, impacts from ship vibrations, protection of medicines and sacred sites, pollution from ships including wastewater, environmental spills and invasive species.

Erosion ESGA has submitted a proposal and requested Environment Program participate in the Oceans Protection Plan.

Akwesasne proposes that Canada participate in a joint study regarding the exercise by Akwesasne of its jurisdiction over environmental protection in the St. Lawrence River in connection with the environmental impacts of navigation.

MCA Environment is partnering on an erosion pilot project to look at nature based solutions for erosion. A “planted crib wall” has been constructed this winter in Mariatown and “ballasted tree structures” will be installed at Point Mouille next winter. This project could continue with implementation at site in Akwesasne. Possible locations are being reviewed.

**Training** - Training for staff is planned for eDNA, Herpetology, Eco Corridor Mapping, Wilderness First Aid, Ontario Benthic Biomonitoring Network, Boat Safety and Man Overboard training by MNR, Aerial and Aquatic Drones

**Outreach** - Earth Day on April 26<sup>th</sup> was a success. the Waste Coordinator held a composting workshop on May 8th and provided composting worm bins to attendees. Staff are handing out to each of the three AMBE schools a vermi (worm) compost bin.

A few staff attended Kids for Fishing 20 children paired with a mentor, SRMT initiative that MCA joined PJ Burns. Promoted Funky Fish Guide and provided information about RAP. Included a benthic station and live touch tank that hand fish.

RAP Workshops continuing this year currently include currently includes overnight fishing in the Otentiks, trapping and butchering, medical plant identification, harvesting, and preparation, wild rice harvest and preparation.

Council meetings continued:

- Participated in a presentation from Dr Horn on the PCBs in our area and what it is doing for our health. Council and programs related are looking at ways we can combat this including test soil for gardens etc. This is ongoing.
- Participated in a meeting on the NYS Land claims internal discussion amongst Council
- There was no Council meeting due to a holiday.
- Participated in the Strategic planning session held at the Best Western in which was all day. Council reviewed the Strategic Plan of the organisation.
- Participated in a meet and greet with Minister of Public Safety held at Iohahi:io. Grand Chief took a quick tour beginning on Kawehno:ke and ended at the district of Tsi Snaihne where a lunch was held and discussions on public safety issues within the community. A presentation on the geographic location and issues that arise from that as well.
- Participated in the Health Fair at the Tsi Snaihne Recreation on May 22<sup>nd</sup>.
- Took a bereavement day beginning on Thursday evening after the Health Fair and again on Friday due to the passing of my Aunt Pauline Lazore to attend her wake and services at the homemakers in Snye.
- Participated in Council meeting on Monday where a number of MCRs were reviewed. There were no presentations at this meeting.
- Participated in the ACFS presentation on their Policy. A number of questions asked and it was stated that Staff worked on the policy to ensure that the areas of concern were in the policy.
- Will be attending the General meeting.
- Will be attending the Housing Authority meeting this week.
- Will be attending the Detox presentation on Friday with Dr Scott at the Detox center on Kawehno:ke.

Participated in the DIHE Portfolio meeting. Attachments at end of the report.

Sunday Warehouse is 100,000 square feet. Detail design is underway that includes two floors. Drawings are being finalized and name will need to be selected.

Kawehno:ke Clinic/MCA Records repository – (CIA#3 site) The Kickoff meeting went well with Consultants. They are starting the feasibility study. DIHE are observing the existing conditions and looking at the existing medical clinic.

Tsi Snaihne Admin Building – DIHE are reviewing the layout from Figurrs new design fee proposal. Offices will include finance and Justice. Housing is no longer included. This will go to the Space Needs committee to confirm programs.

Akwesasne Youth Hub and Youth Centre – DIHE to design a conceptual layout and work with Communications to distribute for a community survey for consultation and gather input on community needs and preferences.

AMS school addition – DIHE has sent out the RFP for design consultants services for the new school addition, and a site visit has been scheduled for April 24<sup>th</sup>. There were many questions received and the submission was extended until May 5<sup>th</sup>. The New Addition will not affect the lacrosse box.

Building Conditions Reports have been done on a number of MCA Facilities. An RFP will be going out to initiate the ISC ACRS Report for all building assets. This is ongoing.

Hamilton Island Bridge drawings are now 80% complete. Waiting for the Archeology report to be finalized.

Iakhihsohta Kitchen renovations – Design is complete and renovations will begin in the spring. The kitchen will be closed during the renovations. Discussions on management procedures during the renovations are taking place. This project is funded and a tender will go out for bids for the Construction phase. The facility is planning for meals for when the project begins.

New Fire Station #3 – Snye Chiefs met with the Fire Department and they do not want a multi purpose building. They had concerns about the survey and they want to go with the original drawings.

Hawthorne Road extension/subdivision site – DIHE is in discussions with ISC on potential reimbursement options for the road site servicing project and a 5-unit housing complex project. There is still a beaver issue in the area.

Kawehno:ke Salt Dome – The Kawehno:ke Salt Dome project is 100% Tender ready. DIHE are working on Project approval documents to ISC. This is ongoing and a submission is needed.

Capital Plan update – Consultants have been meeting with Directors and Departments. A traffic and Roads study is in progress. Smaller road project sections are being looked at. Jp2g will submit fee proposal. The intent is to determine what roads can be designed, funded and constructed this fiscal year.

Iohahi:io Cultural Centre and Outdoor Pavillion – The Tender call was issued for construction with a mandatory site meeting with Contractors this past November. Five Contractors attended. Due to the winter months no bid was received. This project has been retendered and site visits have occurred.

Iohahi:io Portable Classroom Project – This is 99% design completion with Mechanical and Electrical Consultants coordinating work with IDP who are completing the building portables. Foundation, site works and a breezeway connection is Tender ready. This will be in coordination with the Cultural Centre during the spring. Ongoing.

Street Lighting project is being discussed with AMPS due to public safety concerns where the area is not lit up. A survey to determine where street lighting will need to go.

Kana:takon Beach project is tender ready and will go out to Tender in May.

New Snye School – Preliminary design is completed. A community consultation will be scheduled, once 3D elevations are finished by the design consultants. AMBE were informed that funding needs to be sought in order to move forward on design. Project has been halted due to funds.

Roof Condition reports – Snetsinger Consultants has been initiating roof assessments on the Health Facility, Admin 4, Central Police Station and found all are in need of repair. Additional buildings have been added to the list that include CIA#3, WWW plants, AMS School and Snye School. Proposals have been submitted by roofing consultant to DIHE for AMS and Kanonkwatsheri:io health Facility to prepare design/tender ready package. Funds will be needed. This is ongoing.

Roads repairs / replacements - DIHE is working on RFPs to obtain a consulting firm for an Engineer of Record for detail design to achieve tender ready projects for road replacement/repairs for priority roads. There are numerous roads in need of repair in all three districts. DIHE are looking at bundling the project based on the Roads report. The intent is to obtain an engineering



firm for 2 to 4 years to Bundle roads projects to complete design to achieve tender ready projects. JP2G will submit proposal to bundle the roads as confirmed in a meeting held.

Generators - Generator installation completed to Iakhihsohtha, Snye Homemakers, and Tsiionkwanonhso:te. The Kawehno:ke recreation is finally delivered. DIHE are looking at penalty options due to multiple delays to the project.

A'nowarako:wa Arena - DIHE is assisting Ec Dev on the Arena expansion project. DIHE has prepared an RFP for consultant services to achieve a tender ready project for the new arena addition. Ec Dev are seeking funds for a feasibility study. A proposal to the Trust was denied as they do not fund feasibility studies.

Block 97 Sewage Pumping Station – DIHE obtained EVB Engineering to complete a condition assessment report on the existing pumping station which is 30 years old +. The station services the surrounding housing units and the Long term care facility. Detail design to achieve tender ready documents are currently being completed. Project ongoing and waiting on drawings.

Community Water Connections – in collaboration with WWW, OS DIHE and Jp2g consultants. The first priority is waterline connections in Snye took some time to resolve. Drawings are being completed and other residents in Snye have been notified and data, paperwork has been collected. Project is ongoing. Drawings are 99% complete. Ongoing.

Snye Water Study and Distribution System – Capacity condition and risk assessment, includes water tower. Proposal was submitted by Jp2g Consultants as a preventative measure. A contract is being completed. DIHE will continue with the study for Northern residents. WWW will continue to monitor the break in the middle of the river where the pipeline break occurred.

HVAC for Schools - Detailed design for AMS school is ongoing. Funding is needed for this project. Tender ready documents will be ready for summer construction season. Kana:takon School HVAC have drawings and specs ready. If funding is secured, the project will be tender ready. Tsi Snaihne School is tender ready but the Hydro issues is still an issue. Work with Quebec Hydro on the power lines is ongoing. A meeting with Hydro will take place in June.

**Other issues:**

**Portfolio Issues:**

A community raised an issue of the rates of Hydro getting out of hand. Hydro bills are going up and the Community are being affected with this rising cost.

District of Tsi Snaihne resident requested street lights on Whoville and on Hemlock Dr.

Housing needs.

**Additional Updates:**

Talked with a few Community members who want to see working task groups on all Policies that currently are in operation and would like to not have representatives on the task group that the policy affects to ensure fairness.

Talked with a few Community members who have an issue with Council travel. They would like the travel to be only in the event that there is something to be brought back for Akwesasne.

**Other works to be set up:**

Looking to bring the Multi Jurisdiction table back so we can sit down and look at what the Roads needs are in order to go after funding. This has been sent to the Director and it was announced at the DIHE Portfolio meeting in which we all agreed to. This was discussed at Portfolio meeting and agreed that we need funding from all sources. Would like to have phases of projects begin this year and each year moving forward.

- **May 12<sup>th</sup>**, During the Kana:takon District Meeting, community members shared the following concerns:

**Post Office Repairs:** Minor repairs are needed at the local Post Office, and members expressed concern about the lack of attention to this issue.

**Access to Boat Launch Area:** Concerns were raised regarding AMPS (Akwesasne Mohawk Police Service) assuming control of the boat launch area, which has made it increasingly difficult for Elders residing at Sweetgrass to access the site.

**Community Policing and Response:** A community member reported an incident involving an individual knocking on Elders' doors. When reported, the family was informed by AMPS that it was "not within their mandate." The community is seeking clarity on the role of AMPS and whether officers are receiving training in community-based policing.

**Economic Development:** One member inquired about the shipping containers that were received and requested an update on the intended plans for their use.

**Community Infrastructure and Services:** Members shared suggestions for improvements they would like to see in the village, including:

- Paving of Sweetgrass Lane
  - Construction of a multi-purpose building to serve both Elders and daycare needs
  - Upgrades to local playgrounds, including the addition of equipment designed for children with special needs
- **May 16<sup>th</sup>**, Presentation by Dr. Horn on Environmental Pollutants. Dr. Horn delivered a highly informative presentation that effectively highlighted both her expertise and the Department of Health's commitment to raising public awareness about the environmental challenges we face as a Nation. She emphasized the long-term impact of pollutants that have been present in our environment for decades and continue to contaminate our land and water sources. A key takeaway from the presentation was the critical importance of early screening in addressing and mitigating the health risks associated with these pollutants.
  - **May 21<sup>st</sup>**, Strategic Planning Session with Council. Council went through the Strategic Plan, made changes to encompass this council.
  - **May 22<sup>nd</sup>**, AMBE Cultural Day. Great event held by AMBE. Drummers, dancers and a performance by students led by the amazing and talented Feryn King. This event was for K4 – Grade 3 at all three AMBE Schools.

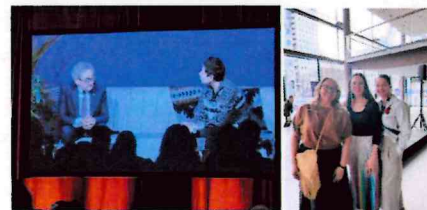

# Chief Report

## Kawehno:ke District

**Reporting Period: March–May**

She:kon,

I hope this message finds you and your loved ones in good health and spirit. I want to extend my deepest condolences to anyone in our community who is grieving the loss of a loved one. My thoughts are with you, and I hope you continue to find strength through family, friends, and our community.

Over the last few months, I've continued to attend all mandatory meetings and participate in my portfolio responsibilities. Below is a summary of my activities and updates from March through May.

- **Coteau-du-Lac Reburials:**

Akwesasne has requested to lead the reburial process for ancestors discovered at the Coteau-du-Lac. Kanesatake and Kahnawake are in support. The Mi'gmaq Nation has withdrawn from the discussions, expressing confidence in Akwesasne's capacity to carry out this important repatriation work. Further meetings are ongoing, and we are seeking full Nation approval before moving forward.

- **Language Revitalization:**

Attended a YECL presentation where passionate community members shared initiatives for revitalizing the Kanien'kéha language.

- **Kanien'kéha Revitalization Group:**

Participated in a meeting with fluent speakers, teachers, and second-language learners working to establish a non-profit organization to support language learning.

- **Fish Population Concerns:**

A follow-up meeting was held with MCA Conservation and Environment to explore seasonal protective measures. This initiative is still in the early stages, and community updates will follow as planning progresses.

- **Transport Canada Session – Entewatatha:wi Table:**

Participated in a session with representatives from Transport Canada (Ontario Region) and the Seaway Authority. ESCWA acknowledged the jurisdiction of MCA regarding

both land and environmental matters. Discussions focused on environmental concerns and the commercial traffic that passes through the seaway.

- **Cairn Island Return:**

Planning is underway for an event with South Glengarry to mark the return of Cairn Island to Akwesasne.

- **Ontario Energy Board – Glendale Subdivision:**

Concerns were raised over the lack of consultation by Enbridge for a proposed natural gas expansion in Glendale, which is on Akwesasne's claimed land. Updates to follow.

- **Entewatatha:wi Negotiations:**

Topics discussed with Canada included:

- Updates to the fiscal agreement
- Concerns about the lack of consultation regarding the divestment of federal properties
- Marc Carney's appointment as Prime Minister and implications for policy
- Confidentiality protocols

- **Minister of Indigenous Affairs Quebec Meeting:**

Key topics included:

- The Quebec language bill – reassurances were given that Akwesasne will not be forced to teach French
- Barriers for healthcare professionals due to language policies
- Support for Indigenous language revitalization
- Potential partnerships with MNR for waterway monitoring

- **CBSA & ARRO Portfolio:**

- CBSA Cultural Awareness Training updates
- Discussions around domestic lane questions, CBSA Border Crossing Initiative, and the Jay Treaty
- ARRO was asked to present the M&M cultural training at the Iroquois Caucus General Meeting



- **Tariff Planning:**  
Participated in strategic sessions addressing customs, ID requirements, and changes related to border crossing and tariffs.
- **Service Canada Territory Violation:**  
Service Canada representatives were found canvassing in Akwesasne without permission and have since been asked to leave.
- **Health Funding Discrepancies:**  
Quebec receives funding on behalf of Akwesasne but does not allocate appropriate health funds to the community. Advocacy is ongoing to register Akwesasne in Quebec's health system to access additional resources.
- **AMBE Updates:**
  - Emergency Council Meeting passed a bilateral multiyear grant arrangement for AMBE.
  - Introduction of the new Youth Council.
- **Kana:takon Membership Board:**  
An election was held to fill a vacant seat.
- **New Vehicle for AMPS:**  
Council approved the purchase of an all-terrain vehicle.
- **Border Partners Meeting:**  
Included representatives from CBSA, U.S. Customs, SRMT, and MCA.
  - Topics:
    - Tariff and ID changes
    - Road Shark monitoring system by U.S. Customs
    - Retirement of CBSA Supervisor Bob Dwyer
- **Akwesko:wa Committee:**
  - Environmental assessments of port lands in Cornwall

#### **RED DRESS DAY 2025: HONOURING MMIWG2S+**

The Mohawk Council of Akwesasne stands in solidarity with communities across Canada in recognizing Red Dress Day, held annually on May 5 as a day of remembrance and action in honour of Missing and Murdered Indigenous Women, Girls, and Two-Spirited People (MMIWG2S+). Red Dress Day brings visibility to the deep injustices and violence faced by Indigenous women, girls, and 2SLGBTQ+ individuals. This crisis has touched every First Nations community and continues to leave lasting pain and trauma in its wake. We honour the lives lost, the families left behind, and the voices that continue to call for justice.

We recognize that this is not only a crisis, but a deeply rooted issue that calls for continued action, accountability, and change. The violence faced by Indigenous women, girls, and Two-Spirited

people has been ongoing for generations and must not be ignored. Their lives matter, and their memories must fuel meaningful change.

As a community, we are committed to truth, justice, and healing. We encourage Akwesasronon to take time on Red Dress Day to reflect, participate, and raise awareness. Wear red, hang a red dress, attend a local event, and stand with the families who carry this pain every day.

The MCA also encourages Akwesasronon to participate in the community display by the Akwesasne Family Wellness Program (AFWP), beginning on Friday, May 2, 2025. This display will remain in place through Monday, May 5, 2025. Families who wish to contribute to the MMIP visual display are invited to take part. Banners will be available for families to honour their loved ones in a personal and meaningful way—through photos, words, or names. Community members are also welcome to bring a red dress to hang.

Individuals can add to the display once it is up, allowing everyone to participate in this important memorial. The display will be set up on the grounds of the basketball courts and along Akwesasne International Road.

### **MARKING MILESTONES: CAREY TERRANCE JR SIGNS IONKWAKWÉ:NION BOOK OF ACCOMPLISHMENTS**

On Wednesday, May 7, the Mohawk Council of Akwesasne and the Saint Regis Mohawk Tribe came together at the A'nowara'ko:wa Arena to celebrate the extraordinary achievements of one of Akwesasne's own — Carey Terrance Jr. The event coincided with the 2025 season home opener for the Akwesasne Jr. B Thunder, setting the perfect stage to recognize a young man who continues to inspire both on and off the ice.

Before the game, Grand Chief Leonard Lazore delivered a warm welcome and presented Carey with a beautifully beaded medallion featuring the Anaheim Ducks logo — a symbol of both his accomplishments and his roots. In his address, Grand Chief Lazore remarked that “we honor one of our brightest athletes” and emphasized the importance of representing Akwesasne with pride and heart. He also gave heartfelt thanks to the coaches, volunteers, parents, and caregivers who uplift youth sports in the community, saying their time and dedication leave a lasting impact on the next generation.

The evening was made even more meaningful with the reintroduction of the ***Ionkwakwé:nion*** Book of Accomplishments — a tribute to Akwesasronon who excel in academics, athletics, arts, culture, and leadership. Reviving this cherished tradition, Carey was the first to sign the book under the current Council, making his mark not only in the world of sports but also in community history.

Carey Terrance Jr. is no stranger to success. At just 19 years old, he has earned gold with Team USA, played in three IIHF World Junior Championships, and signed a three-year NHL contract with the Anaheim Ducks — making him the first Akwesasronon to reach these historic milestones. The celebration took place on the very floor where he once played both hockey and lacrosse as a youth — a full-circle moment that touched the hearts of all in attendance.



What sets Carey apart isn't just his talent, but his unwavering humility, strong work ethic, and connection to home. He carries Akwesasne with him wherever he goes, serving as a powerful symbol of perseverance and possibility for Indigenous youth across Turtle Island.

During the first intermission, the Saint Regis Mohawk Tribal Chiefs presented Carey with their Hometown Hero Award, recognizing individuals who embody hope, perseverance, and commitment. Following the ceremony, Carey Jr. was welcomed by fans of all ages during a community autograph session, where he graciously signed cards, hats, jerseys, and more — leaving many with memories to treasure and stories to tell.

Carey's journey is a testament to what can be achieved with discipline, determination, and heart. His story reminds us that greatness isn't just about breaking records — it's about lifting others up and staying grounded in who you are and where you come from.

To the youth of Akwesasne: dream big, work hard, and never lose sight of your goals. With determination in your spirit and the support of your community behind you, there are no limits to what you can achieve.

### **MCA FAMILY SUSTAINABILITY PROJECT**

The Mohawk Council of Akwesasne is committed to supporting our community during these challenging times. In response to the rising cost of food driven by inflation, global tariff concerns, and the unfavourable currency exchange rate, we are pleased to announce a one-time assistance payment of \$1,000 to help community households manage these challenges.

This initiative aims to provide immediate relief to families facing increased grocery expenses and economic uncertainty. We recognize the financial strain many are experiencing, and we are taking this step to help ease the burden.

### **Who is Eligible?**

Each Head of Household that is currently listed on the Akwesasne Heating Assistance Program (AHAP) eligibility list.

**How to Receive Assistance:**

For those who are on the existing AHAP list, there are no additional steps required at this time. If you did not receive AHAP funds, any eligible Heads of Household are invited to contact us, provide proof of eligibility, and request to be added to the list. For those who were not on the most recent AHAP list but are eligible, the deadline to be added is **June 6, 2025**.

Cheques will be distributed by MCA Chiefs at designated district locations during the week of June 16, 2025. Detailed distribution dates and times will be provided in the near future.

MCA remains committed to supporting our community by providing meaningful assistance to Akwesasronon during difficult times. **Border Partners Monthly Meeting- MCA, SRMT, CBSA, USCBP**

May 2<sup>nd</sup>, 2025 Zoom

Discussion around creation of record increase of requests by community members born in Canada with dual citizenship have been on the rise due to Licenses, FAFSA education funding and employment. Council stated that the creation of record as known as green card is not a avenue Council supports community members to proceeding with as it violates our standing Jay Treaty Agreement. Further joint discussions will continue this subject.

As of May 7<sup>th</sup>, 2025, a Real ID is needed for any domestic travel within US, forms of Real ID are enhanced drivers license and passport. It was noted that Red Card and Tribal ID will no longer be accepted for domestic flights and only honored as travel identification when traversing through land border crossing.

The Mohawk Council of Akwesasne is committed to keeping the community informed on matters that may impact travel and border-related activity. At the recent Border Partners Monthly Meeting held on May 6, 2025, several important updates were shared by Canada Border Services Agency (CBSA) and United States Customs and Border Protection (CBP).

The CBSA has advised that there may be some traffic disruptions on May 20, 2025, related to commercial transport trucks that are not currently enrolled in the new CBSA Assessment and Revenue Management (CARM) program. However, they've assured that local traffic should remain unaffected.

In addition, CBSA will begin upgrading license plate readers starting June 16, 2025. This work will be completed one lane at a time, with only a single lane impacted each day. While this may result in minor delays, the goal is to maintain traffic flow and minimize inconvenience to travelers.

On the U.S. side, the CBP shared that a new 90-day pilot project is underway with the installation of a “Road Shark” device. This tool is designed to deter vehicles from attempting to flee southbound by using the northbound lane. The device targets such illegal maneuvers and will not affect regular northbound traffic. The effectiveness of the project will be reviewed at the end of the 90-day trial period.

The Mohawk Council of Akwesasne will continue to share updates with the community as they become available. We thank you for your attention and encourage you to plan ahead for travel during the mentioned dates.

### **REAL ID REMINDER: KNOW BEFORE YOU GO**

Starting May 7, 2025, the U.S. Department of Homeland Security will enforce the REAL ID Act. If you're planning to fly within the United States, you'll need to show a REAL ID-compliant card or another acceptable form of identification at TSA checkpoints.

Good News for Akwesasronon:

You do not need a REAL ID to fly domestically if you have one of the following:

1. Tribal ID (issued by the Saint Regis Mohawk Tribe)
2. Canadian Status Card (issued by the Mohawk Council of Akwesasne)

These cards will continue to be accepted for U.S. domestic flights as they are federally recognized forms of identification.

What is REAL ID?

REAL ID is a U.S. federal law that sets new security standards for state-issued IDs like driver's licenses. After May 7, 2025, only REAL ID-compliant licenses or other approved IDs will be accepted to:

- Board domestic flights in the U.S.
- Enter secure federal buildings
- Visit military bases

REAL ID cards have a star marking on the top of the card.

Not REAL ID Ready?

You can still use:

- U.S. passport or passport card
- State-issued Enhanced Driver's License (EDL)
- Federally recognized tribal IDs
- Indigenous Services Canada status cards
- NEXUS/Global Entry cards
- And more...

To avoid delays or missed flights, be sure your ID is on the TSA's list of accepted documents.

### **AKWESASNE ELECTION LAW UPDATE & NEW OVERSIGHT COMMITTEE MEMBER**

In pursuit of fair and just laws for our community, the Akwesasne Justice Department (AJD) called for a Tsi Snáihne district community member to serve on the Oversight Committee on Legislative Development. This Committee is comprised of appointed community representatives and Council who draft legislation to protect and advance the inherent rights of the Mohawks of Akwesasne, guided by principles of peace, respect, and fairness. We are pleased to announce that the successful candidate to represent Tsi Snáihne is Theresa Benedict.

Theresa has been a vital researcher with the Akwesasne Rights and Research Office (ARRO) since October 2018, working to preserve Akwesasne's history and cultural heritage while providing educational materials to the community. Her contributions to key projects like the Dundee-Tsi:karistisere and St. Lawrence Seaway Referendums highlight her dedication to advancing the community's interests. Theresa also supported individuals involved in the Federal Indian Day School Class Action, offering guidance with care and commitment. Her ongoing efforts to protect Akwesasne rights and celebrate its culture will bring valuable insight to the OSC.

We are excited to welcome Theresa to the Committee, where she will oversee and receive Council and community input, provide community guidance and direction in the development of Akwesasne Laws, and consider and balance the diversity of perspectives. Niawen:kówa for your commitment to the community of Akwesasne, and congratulations Theresa!

### **UPDATE ON THE AKWESASNE ELECTION LAW (AEL):**

Now that the required community representation is met for the Committee — with one member from each district — work can commence on the AEL Amendment(s). According to the Oversight Committee on Legislative Terms of Reference (TOR), “In order to conduct business for the Oversight Committee, a quorum of three Oversight Committee members is necessary.”

Since the four other members of the OSC are Justice Portfolio Chiefs, it would be a conflict of interest for them to work on the AEL. Therefore, quorum could not be met to establish a working task group (WTG) until a new Tsi Snáihne District member was accepted through MCR to serve on the OSC.

The next official OSC meeting will be held this week to discuss forming a Working Task Group (WTG) for the AEL. Along with the three district representatives, WTG members will include MCA staff who serve as administrative and technical support. This team will help guide the amendment process. Moving forward, the AEL WTG will address the petition and decide how to proceed. We appreciate your patience and will provide the community with another update as soon as possible.

## Justice Portfolio

There has been extensive work on the **Eniethihswanon:na ~ Child's Rights Law** over the past few years. The law supports the inherent right to care for our Ratiksa'okòn:'a (Akwasasne Children) based on our traditions, principles and values, and have maintained jurisdiction over our Ratiksa'okòn:'a. The law is a critical step in exercising jurisdiction over Kaksà:ta (Akwasasne child) and Kahwá:tsire (Akwasasne family) matters for the Mohawks of Akwasasne. The Akwasasne Law Enactment Procedural Regulation (ALEPR) will be followed for the development of the law.

The Law is in **Phase 1: Law Development Phase** and underwent the Legal Review. The next step is to present to Council for Post-Legal review. Please see the steps that are followed in the chart.

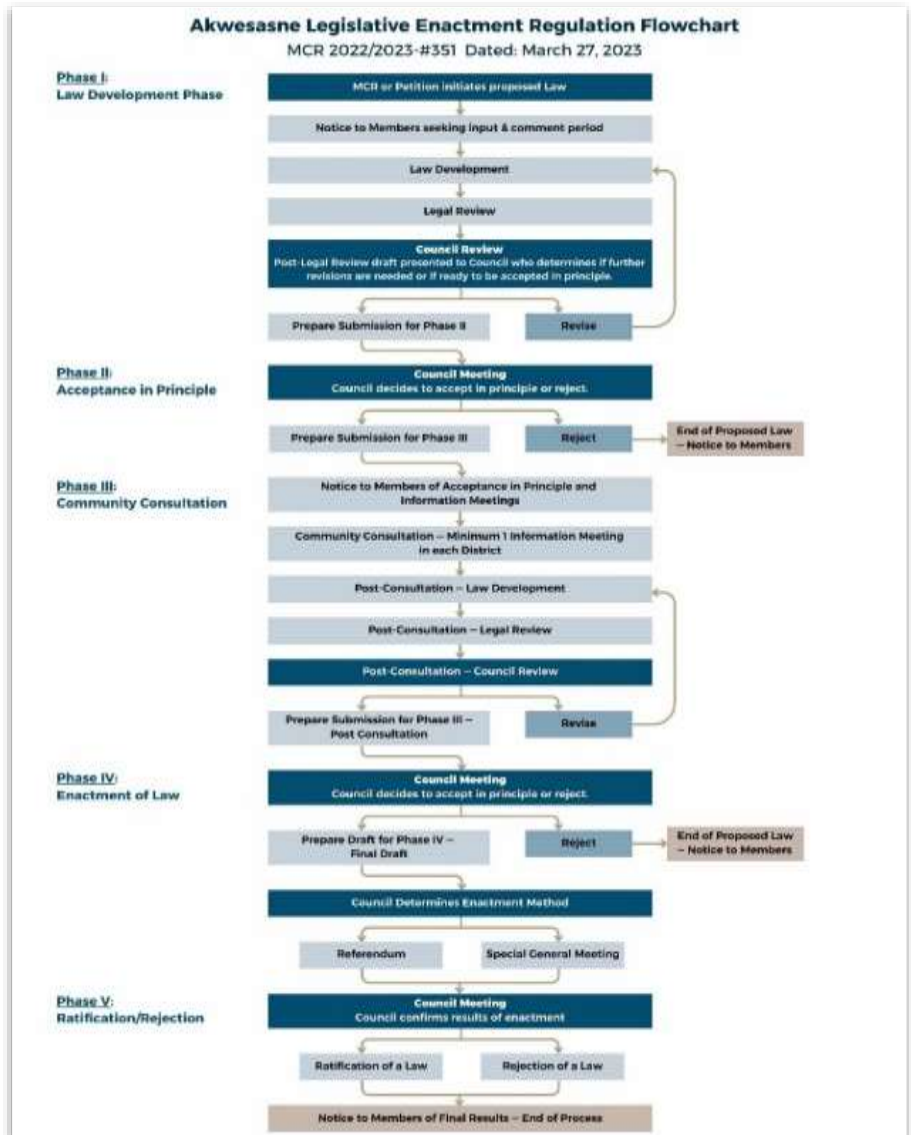

## **Enbridge Funds – A Brief History**

Through MCR 19-10 # 052 dated May 29, 2009, the Mohawk Council of Akwesasne approved a formal agreement between the Mohawk Council of Akwesasne (MCA) and Niagara Gas Transmission Limited (NGTL), a subsidiary of Enbridge Inc., regarding the operation and potential relocation of a natural gas pipeline through Akwesasne Territory.

Here are the key points summarized:

### **1. Recognition of Jurisdiction and Rights**

- The MCA asserts its inherent right of self-determination and jurisdiction over its lands and people.
- NGTL acknowledges this authority and seeks to work collaboratively with MCA on the pipeline project.

### **2. Purpose of the Agreement**

- To formalize cooperation between MCA and NGTL regarding the pipeline that runs through Akwesasne Territory.
- To ensure MCA's meaningful participation in planning, environmental assessments, and decision-making related to the pipeline.

### **3. Pipeline and Project Scope**

- The pipeline, in operation since 1962, runs through a highway corridor managed by the Federal Bridge Corporation Limited (FBCL).
- NGTL is considering relocating the pipeline due to the planned replacement of the North Channel Bridge.
- The agreement includes provisions for continued operation, potential relocation, and future natural gas distribution within Akwesasne.

### **4. Financial Commitments**

- NGTL will make a one-time infrastructure contribution of \$1 million, contingent on MCA's consent to the new bridge construction and regulatory approvals.
- Annual payments of \$100,500 will be made to MCA, adjusted annually based on the Consumer Price Index.
- NGTL will also fund environmental assessments and a joint committee to explore natural gas distribution opportunities (up to \$75,000).

### **5. Environmental and Safety Provisions**

- A harmonized environmental assessment (HEAR) will be conducted jointly.
  - NGTL commits to using best practices in design, construction, and emergency preparedness.
  - MCA will participate in safety planning and environmental oversight.
- 

## **6. Economic Development and Employment**

- NGTL agrees to use Akwesasne contractors and promote local procurement.
- A community survey and feasibility studies will assess interest in local natural gas service.

## **7. Dispute Resolution and Term**

- The agreement is valid for 20 years, with provisions for extension and arbitration in case of disputes.
- NGTL may terminate the agreement under specific conditions (e.g., regulatory changes, insolvency of affiliates).

## **8. Confidentiality and Liability**

- Confidential information, especially traditional and sacred knowledge, is protected.
- NGTL assumes liability for pipeline-related damages and must maintain \$100 million in liability insurance.

This agreement represents a significant step in formalizing the relationship between MCA and NGTL, ensuring respect for Akwesasne's jurisdiction while enabling infrastructure development and economic opportunities.
