AANDC Minister Valcourt Visits Akwesasne

The Honourable Bernard Valcourt, Minister of Aboriginal Affairs and Northern Development, joined Grand Chief Mike Kanentakeron Mitchell of the Mohawk Council of Akwesasne for a tour of the Mohawk Nation of Akwesasne on August 6, 2013.

"Our government is working with Akwesasne to advance our shared goals and improve economic development opportunities, said Minister Valcourt. "I would like to thank Grand Chief Mitchell and all of Akwesasne for the warm welcome I received during my visit. The work done by leaders within the Akwesasne community is paving the way to advance economic interests."

Both parties discussed shared goals of increased economic development opportunities through tourism and local infrastructure projects. Also, the priority to improve quality of life through community initiatives like the leading water treatment facility, and by addressing barriers such as border accessibility were addressed.

Following yesterday's introductory meeting with Minister Valcourt the Grand Chief commented, "The Mohawk Council of Akwesasne is very appreciative to have had first hand introduction to Minister Valcourt in Akwesasne. We were pleased to have the opportunity to show the Minister the geographic and multi-jurisdiction challenges we face. He now understands the unique geographical issues that are attached to having an international border crossing in our community. We have unique problems/situations that call for creative solutions. We look forward to working with the Minister to find creative, reasonable solutions to Akwesasne's border and community issues."

Akwesasne has approximately 11,000 members. The community has a unique jurisdictional and geographical situation due to its location. The border between Canada and the United States runs through Akwesasne and the Ontario/Quebec provincial border also runs through Akwesasne reserve land within Canada.

I hope this month's edition of Onkwe'ta:ke find you and your family in good health and spirits. With the fall season upon us, I'd like to remind everyone to drive safely as our children are headed back to school.

As a Kanienkeha speaker I am very passionate about the preservation and restoration of the Mohawk language. As part of our language initiative MCA hosts daily language lessons in partnership with the Akwesasne



Economic Development Agency. The community of Akwesasne is invited to join the Can 8 language classes for \$20 per month. A beginner's session will begin on September 9th. To register please call the AEDA office at (613) 932-2923 or email Joanna@aeda.ca. I really wish Akwesasronon could find the time to utilize the Can 8 language program.

As a Tsi Snaihne district chief I hold the portfolio for Tehotiienawakon and am part of the Environment committee. Unfortunately there are many species at risk in our waterways and one of our major concerns is the sturgeon. We need to do all we can to maintain the population of sturgeon. Please keep in mind that if you catch a sturgeon with a tag on it please forward the following information to our team at the Environment program – the length, weight, location of where it was caught and the time of year.

We are also awaiting a report from the St. Lawrence River Institute summer students. The summer students were routinely checking walleye for Mercury levels. Their report will tell us if new fish advisories are necessary in certain locations and times of year. We are looking for funding to restore walleye spawning beds and recognize the need to educate the community on this issue. Lastly, we will be updating the Conservation Law and a draft may be ready in October. The current Conservation Law has been in place since 1985 and there is a need to update.

Enjoy the last days of warm weather. With colder weather approaching you may be able to make room in your busy life to learn your language. Please remember to take great precaution when driving on our roads as the school busses will be out picking up and dropping off our children. In this issue of Onkwe'ta:ke you will find back to school information and school bus safety.

Notice of Community Consultation Meetings

The Mohawk Council of Akwesasne hereby gives notice of Community Consultation Meetings for the proposed draft 'Akwesasne Traffic Law'.

The 'Akwesasne Traffic Law' Working Task Group has completed their mandate to develop a comprehensive traffic law that has been presented to Council for acceptance in principle in accordance with the Law Enactment Procedural Regulations Section 10.0 Amendment and Repeal of an Akwesasne Law. The proposed draft was accepted-in-principle at the July 31, 2013 General Meeting by Mohawk Council Resolution 2013/2014-#143.

The proposed draft law will now proceed to Phase III of the Law Enactment Procedural Regulation.

The Akwesasne Justice Department will be mailing copies of the proposed draft 'Akwesasne Traffic Law' to every household. If you have not received a copy in your mailbox, you can request a copy of the draft law to be mailed to you, personally. Contact the Akwesasne Justice Department at 613-575-2250 x. 2400 with the relevant mailing address so a copy can be delivered to you. Residents are asked to review the proposed draft law prior to the Community Consultation Meetings.

Following the review period for the proposed changes, a series of three Focus Meetings (Community Consultation Meetings) will be held, one in each district of Akwesasne. These

meetings will provide community members the opportunity to ask Council and the Working Task Group questions on the proposed draft law, as well as giving the community the opportunity to provide comments and suggestions.

The sessions will be recorded and the comments will be given to the Mohawk Council of Akwesasne for consideration. The Working Task Group will then incorporate any recommendations by the Mohawk Council of Akwesasne, with the draft changes being reviewed by the Mohawk Council of Akwesasne's Legal Advisor. Once complete, the changes will be presented to Council for adoption and/or for further revisions.

If the Mohawk Council of Akwesasne accepts the revisions/recommendations, a Mohawk Council Resolution will be presented at a future General Meeting to accept the final draft in principle for ratification. Once accepted, Council will set a date for a vote by secret ballot at a Special General Meeting or vote by Referendum.

The dates of ratification vote by either method must be posted at least thirty days in advance. A full text of the proposed final law will be published in the local newspaper and on the Mohawk Council of Akwesasne website.

DEPARTMENT OF COMMUNITY AND SOCIAL **SERVICES (DCSS)**

n July 8, 2013 Chief Phillips-Jacobs, the Director **U**of DCSS, the program manager for lethinisten:ha Family Wellness program, and I met with a Regional Manager for the Ministry of the Attorney General to discuss the Partner Assault Response (PAR) program delivered by the Family Wellness program in Akwesasne. We had been advised of concerns related to the delivery of the PAR program at a recent portfolio meeting and agreed to meet with the ministry to discuss the future of the PAR program. Existing statistics indicate that the number of Akwesasronon accessing the program has been consistently decreasing over the years. The potential risk to employees however, remains the same because non-Akwesasronon continue to access the program. The ministry has now been informed of our intention to discontinue the delivery of the PAR program. We also notified them that we are of the opinion that if any of our community members do need to access a PAR program; this service could be effectively provided by our community partner, the Counseling and Support Services of the United Counties of Stormont, Dundas, and Glengarry. Negotiations have already started in order to ensure that culturally appropriate PAR program services could be provided to Akwesasronon through priority seating in Cornwall. The representative from the Ministry of the Attorney General informed us that a formal request to reallocate resources to the Counseling and Support Services of the United Counties of Stormont, Dundas, would have to be forwarded to the head office in Toronto in order to make this happen. We drafted this letter and sent it to the ministry and are currently awaiting a response.

AKWEKS:KOWA

On July 10, 2013 the Board of Directors for the Akweks:kowa corporation held a regular meeting to discuss business that has occurred over the last year. I currently sit as a director for the board. Akweks:kowa is a MCA wholly owned subsidiary that was originally set up for the coffee roasting business MCA undertook year and was catered by a community member.

several years ago. The corporation is now used as a holding company, meaning that it is used to hold nonreserve lands for MCA. Under the rules of incorporation an annual meeting of the board of directors and shareholders must occur in order to conduct routine corporate business. The board discussed whether MCA should continue to utilize Akweks:kowa solely as a holding company or expand its uses to include other business ventures that have the potential to generate a profit. Any decisions on these options would be deferred to Council for consideration.

MOHAWK GOVERNMENT

On July 24, 2013 I participated in an orientation session at the St. Regis Recreation Center hosted by the staff of the Mohawk Government program. The purpose of the session was for each of the staff members to provide an overview of the roles and responsibilities to Council to increase the level of understanding and offer insight as to exactly who is responsible for what so that Council members are clear on who to see depending on their specific need for assistance. Similar orientation sessions are reportedly going to be delivered to each department within MCA to inform other MCA personnel of the roles and responsibilities of the Mohawk Government program personnel, to improve the flow of information, and improve overall communications.

EDUCATION

On July 29, 2013 we hosted the 2013 Student Bursary Presentation which is an annual event co-sponsored by the Bank of Montreal and Enbridge Gas. Each corporate sponsor provides five (5) bursaries in the amount of \$1000 each. The bursaries are awarded to ten (10) deserving high school graduates continuing their education in a post secondary institute. The Student Bursary Presentation provides the opportunity for the Ahkwesahsne Mohawk Board of Education (AMBE) personnel, the AMBE Trustees, and Council to personally congratulate the recipients and for the corporate sponsors to meet them and their parents as well. - -Trying to get meeting with Tribe regarding land claims ruling. It is a victory but we still lost an awful lot. Appeals, etc. are in the works. It would be beneficial to put out joint releases.
- -Held first Trust Technical Team Meeting with Overseers. Very informative. Consultant and lawyer were on teleconference. We have good quality people. We mapped out what they will be tasked with and discussed how trustees will be chosen.
- -Received a visit from an individual who wants to participate in a reality TV show in Akwesasne. I asked what the intent is of the TV show, if it's to sensationalize things here. The individual wasn't clear. I offered to bring the individual to full Council to present the idea. I told the individual people have wanted to do shows here before and their interest is the smuggling.

Chief Joe Lazore

- -Attended ETA workshop at casino. More of an environment technical meeting.
- -Held District Meeting. Community members are asking for a Quebec doctor because they're being charged when they go to Ontario hospitals. They're being asked for credit cards to back up payment.

Chief Karen Loran

-Attended Political Confederacy Meeting in Niagara Falls. Many topics discussed. I'm concerned with First Nations Education Coordinate Unit. Chief Louise Thompson asked our Council previously about the

Education Act that is going to be passed and if there was a recommendation to have our own education law created in Akwesasne. If this Act is passed, will it supersede agreements Canada has with First Nations? We have our own Education system. We need to get on board with our education director to find out what his concerns would be if new legislation comes down. They're (PC) trying to put together another First Nations Education Summit to take a look at this. We need to get on the table with a lot of the issues brought forward at these PC meetings.

Grand Chief comments: We need to ask our Director of Education if we are in a position to ask for exemption from that legislation. If we come under that legislation it's a matter of coming under their criteria, reporting everything, and we're back under their system again. It took us a long time to get our own education system. That would all change if we don't get an exemption. We will raise this with the Minister visiting next week. We reserve the right to seek exemption but I can't go much further because we don't have a position yet from our Director of Education.

Chief Abram Benedict comments: Staff was also going to look into the steps needed to include education in the Entewetathawi process. We also don't know yet what the legislation will say.

- -Request made at PC meeting to share our policing commission charter/history
- Met with three community members regarding personal issues/concerns
- Approached by community member concerned about Cornwall Electric bill. Bill is high for a one-person home. A petition was presented to Council previously on this topic. This person wants to know what MCA can do because the rates are going up.

Grand Chief: A chief from each district should take a look at it. We could form a committee on the issue. Chief King: This was raised with OPG as well as our Quebec partners so options are being explored. Chief William Sunday

- -Received complaint again about schools not having air conditioning.
- that our schools should teach English for 40 minutes and the rest in Mohawk. Personally, I think 50/50 would work or a good portion to be in Mohawk.
- -Individual complained that they received visit from Healthy Homes Initiative but did not receive any further instruction

Chief Florence Phillips: When HHI investigates a house they rank them in priority and that determines which house is repaired first.

Grand Chief: There should be a monthly HHI report in Onkwe'ta:ke updating community members.

Chief April Adams-Phillips

- -Received email regarding land trade.
- -Attended workshop at casino hosted by St. Regis Mohawk Tribe
- -Met with Economic Development staff regarding community member's business proposal
- -Approached by social worker asking if we had petty cash for community member in emergency situation with no food. I said I didn't know about petty cash but offered money. I think we need to establish something that allows us to donate money out of our paychecks to go to things like this.
- -Attended Tsi Snaihne District Meeting. There were many DTS issues brought up and waterline issues/ complaints.
- -HHI issue Community members just want feedback regarding what the next steps are.

Chief Julie Phillips-Jacobs

- -Attended Bursary Presentation.
- -Education In regards to education and comments made for air conditioning, not every home has air conditioning and every effort is/ should be made to ensure that the children are comfortable. Need to be creative and plan activities accordingly. Air conditioning in the building would fall under maintenance of the buildings(DTS) and I'm not sure that it would be feasible. Mohawk language has made great strides within our schools. Parents have the choice to send their children to our Skawitsira program which the enrolment has been on a steady increase. It has come a long way. Its also important to make sure everything possible is being done in the home. There are only so many hours in a school day.

Chief Louise Thompson

-Attended District Meeting. We heard complaints regarding the crossroads and that there will be serious injury there someday. There are speeders, and vehicles that don't abide by the traffic rules etc. Community -In regard to education, it was recommended to me member who had their vehicle seized asked for help from MCA. I advised them that they need to file the appeal so they don't miss the deadline. Addressed issues on contradictions of Couples Property Law, mainly the definition of common-law. There are no longer any fees at Barnhart Beach. Maybe we can inform community members.

-Attended PC meeting in Niagara Falls. Discussed 30 percent funding cuts. Discussed 250th anniversary of Royal Proclamation. Invitation from INAC to participate, but at PC table it was stated we do not want to commemorate that document. We do not celebrate the document. We should have our own celebration supper, international powwow etc., to show non-native people that we are still here, we survived assimilation efforts. Will ask ARRO for recommendation on Royal Proclamation. Discussed Nation Building. Also discussed treaty rights commission and issues surrounding that. Discussion with First Nations Education Commission and their concerns with the proposed federal Education Act. They also suggested a task force be formed to look at the structure of the

-Several families (residing on Canadian side) who applied for child tax are having issues. Children may have been born on US side but they have status cards. Canada Revenue Agency is denying them, said the status card doesn't mean they are citizens. It's an interesting situation. Needs legal review.

Grand Chief Mike Kanentakeron Mitchell

-Met with Deputy Ministers in Toronto and new Regional Director General last week. Main item on my agenda was financial reporting study that was being prepared by one of their staff who then retired and no one has picked it back up. Deputy Minister said he is well aware of Akwesasne's good name in reporting. Ontario RDG said she wants to pick up that project on reporting, enter into agreement for Akwesasne to be a model for reporting. She wanted to discuss other possible pilot projects. Discussed upcoming visit from Minister of Aboriginal Affairs Bernard Valcourt. They were not aware, and said Akwesasne should sign Agreementin-Prinicple if Valcourt is visiting. I said we will not

sign yet. The previous Minister promised to advocate Chief Louise Thompson for Akwesasne, and now we have a new Minister. We etc....The next day the Assistant Deputy Minister then called and pressured me to think about signing the AIP because Minister Valcourt is travelling across country etc. I explained why we aren't signing now. When we get things back on track and get commitments from the new minister on how he is going to advocate for Akwesasne, then we will sign. They said fair enough. We have a right to safeguard our interests. They want to come to Akwesasne to talk about other areas they can use as a model. One is the water treatment plants. They're experiencing difficulties with other First Nations in that area. Deputy Minister asked if we can help train, I said yes, but we will charge you. I raised concerns about waterline. Deputy Minister said it will be difficult to write letter making promises in that area but that we can continue working piece by piece. Discussed status cards. Told them we need more because of our large population and that we handle our own, with a backlog. Deputy Minister said he can send a truck to Akwesasne with secure status cards. I said we aren't interested; we are trying to develop our own cards. He said Akwesasne is trying to get out of the Indian Act and that Canada will never go along with our own card. That was one area we didn't agree on. I said we live in a geographic area that others can't fully appreciate. That's another reason we need a full day visit from Minister Valcourt.

August 6 Special Meeting

-Regarding Chief David's Armed Forces meeting, I told them we aren't interested in being a stepping-stone to get into the Canadian Military. In the earliest time, the Iroquois were allies with the British. I told them we still see our relationship the same way. If you're going to set up a program that trains youth on military right, which is like advanced Boy Scouts, plus education, I will need to add cultural awareness, being aware of nations history etc. We want them to come back from this training knowing more about their nation, not about Canada. I said I don't mind having both but the trouble I have is how you're looking at this as a training ground to get into the military service. They also said the program is in place at other First Nations and it is geared toward low-income or single parents or young people disadvantaged in some capacity needing help. It pays up to \$100 a day.

- -CBSA Duty to Report I put a letter together to the Minister reminding him that he committed to contact the Minister of Public Safety. We will also follow up with a phone call requesting another meeting with the minister in Ottawa.
- -We talked with our lawyers to look at what is a class action as it relates to treatment from CBSA. What has changed in recent months to make them so aggressive? Strip searches, etc. We asked our community advocate to make a list of recent human rights issues.

Kawehno:ke Chief Brian David Presents at IJC Water Plan Hearing Hosted by Akwesasne

The International Joint Commission (IJC) held a warnings. He shared with the Commissioners that ■ hearing on its new Lake Ontario-St. Lawrence River water management plan at the Tri-District Elders Lodge on Kawehno:ke (Cornwall Island) on July 19th. The regulation strategy, Plan 2014, proposed by the IJC will attempt to mimic natural flows in the lake and river rather than keeping levels advocated for a First Nation/Tribal representative steady within a relatively narrow range.

Kawehno:ke District Chief Brian David presented on behalf of the Mohawk Council of Akwesasne at the hearing. Chief David provided an overview of the Akwesasne community and discussed the jurisdictional complexity of the community as it is located in two provinces, one state, and two countries. He explained the three Mohawk governments that are in place at Akwesasne.

of Akwesasne was still discussing the IJC's Plan 2014, the Council saw the benefits to it and strongly river versus a lake environment. He pointed out that the community understands the value of wetlands and the role they play in keeping the waters clean and supporting the diversity of species.

Chief David mentioned the community's ongoing proposed Great Lakes Protection Act. concern for erosion of several islands in the St. Lawrence River and along the southern shore of the river. He shared a 2006 Shoreline Erosion Report Council is looking for opportunities for collaborating with others in developing plans to address shoreline erosion and that he would appreciate any technical assistance if it became available.

Chief David shared with the Commissioners that Akwesasne has two water treatment plants, one on Kawehno:ke and one in Kanatakon, that draw their water from the St. Lawrence River. He asked the IJC to be aware of these facilities as they engage in planning and other activities that may affect them.

Chief David spoke about Akwesasne's strong interest in projects to address climate change in the vicinity of the community. He mentioned the Ice Storm of 1998 that the community lived through and the concern that extreme weather events are occurring more frequently, including tornado

Council has its own Emergency Measures Office and that it is willing to work with others in planning for emergencies.

Chief David spoke about the International Lake Ontario - St. Lawrence River Board of Control and on the board. He mentioned that such a voice is not present right now and it can lead to more informed decisions by the Board of Control.

Chief David discussed Species at Risk and that Council was starting a three-year project to look at five turtle species, one bird species, and one plant species. He shared the partnership approach that was being taken between Akwesasne, provincial, and federal agencies in support of the project. He Chief David stated that while the Mohawk Council added that Council welcomed the opportunity to work with others on species protection.

Chief David asked the Commissioners to consider supports the effort to mimic natural flows of the First Nation participation as it works to create an Adaptive Management Plan. He gave examples of how First Nations were advocating for a First Nation Annex to the Canada-Ontario Agreement for the Great Lakes and for greater inclusion in Ontario's

Chief David mentioned that the St. Lawrence River is the heart of the Akwesasne community and that the fishery is important to the community. He that showed the problem and mentioned that expressed Council's willingness to engage in studies that may improve the fishery and asked the question how changing water levels in the St. Lawrence River would impact the fisheries?

Other presenters included representatives from the Saint Regis Mohawk Tribe's Environment Division representatives from the Mohawks of the Bay of Quinte, and representatives from the 1000 Islands Boating Association.

The public comment period on the IJC's Plan 2014 ended on August 30, 2013 and then the IJC intends to make a recommendation and seek concurrence from the United States and Canadian governments this fall on its plan. 💸

The MCA Case Management is a partnership between MCA Department of Health and MCA Department of Community and Social Services. The team hosted a Community Care Day that was part clothing drive and part soup kitchen. They chose to have the Community Care Day at the St. Regis Recreation on August 20th the same day as the Green Food Box distribution to bring in as many community members as possible.

The team recognized the need for back to school clothing and interview clothing for struggling Akwesasronon. MCA employees were invited to clean out their overflowing drawers and closets of chaos for this great cause. Frontline workers were able to identify those in greatest need and invited them to look through the clothing before the public was due to arrive.

Community Support employees were in the kitchen serving up enough soup and sandwiches to feed 200 people. This time around the Community Support Program bought all the ingredients and supplies. In the event of another Community Care Day it is their hope that local businesses will eventually donate the supplies. They also envision the soup kitchen to be run entirely by volunteers.

"It was so nice to get out of the office and give back. Today was out of the ordinary for us. We were here do something positive because we seem to have a negative image," commented Shelley Rourke, Intake Worker for the Community Support Program.

The Case Management has many similar projects in the works in the near future. They hope to hold

The furniture would go to those in need and the team would make sure that the item fits in the recipient's home and make sure that they are in need.

Due to lack of storage space they cannot take any and all donations. One day they hope to have the space to accept gently used clothing, furniture and food donations. Throughout the Community Care Day a small survey was handed out to gauge public opinion on need and whether or not community members would use any of these services. The results of the survey are being compiled and will be shared with the community at a later time.

notification of existing and upcoming local, regional, national, and international opportunities available to the Youth of Akwesase. Each of the MCA Youth Representatives will serve a two year term.


Message from Community Health Nurses

You, as a parent, are going to be in charge of preventing, identifying and treating head lice on your child (ren). MCA Community Health will be here every step of the way to help support you in your new role as "Head Caretaker" (so to speak).

We have lots of information on how you can teach your child to help prevent head lice by not sharing hats, combs, brushes, etc., We have info on how to identify head lice, i.e. what is and what isn't nits & lice. We also have info on current treatments Kanonhkwatsheri:io in Kanatakon. available, what works & what doesn't work.

Do you know if your child is a member under the Akwesasne Membership Code?

If your child was born after April 17, 1985 and one of the following applies:

- Child's mother or father is non-native, or
- Child's mother of father is from another First Nation, or
- There is no father indicated in your child's records

Your child is not a member. Since they are not a member, they may not be eligible for some services.

What's the difference between Indian Status and Akwesasne Membership?


Indian Status entitles you to benefits like non-insured health benefits and tax exemptions.

Akwesasne Membership rights and benefits include those listed above as well as residency, land ownership, voting privileges, post-secondary education assistance.

How do I apply for Akwesasne Membership for my minor child?

September 2013

Applications can be picked up from the Office of Vital Statistics, Cornwall Island Administration Building #3 (CIA#3) Kawehnoke. The application will be forwarded to the Akwesasne Membership Board in accordance with the Akwesasne Membership Code. The applicant must attend a meeting with the Akwesasne Membership Board. A minor or dependent child, who is under 18 years of age when their application is received, does not have to complete a probationary period of 5 years.



Hazard Help Sheet School Bus Safety

IT'S THAT TIME OF YEAR AGAIN! So, parents are preparing to send kids back to school and school buses are a popular means of transportation in Akwesasne and the surrounding communities, but school bus safety starts before the bus even arrives at the bus stop. So, parents, please help us by reading these important Bus Safety Tips with your child (ren).

- * Never play in the street / road while waiting for your bus.
- * Always line up in front of the bus and never alongside it. The driver needs to be able to see you!
- Never enter onto the bus unless it has come to a complete stop and the red caution lights have been activated.
- * Walk slowly up to the bus and climb the stairs. Pay attention to your footing and listen for directions from the bus driver.
- * Entering onto the bus, quickly find your seats and use seatbelts if provided.
- * Share your seat if someone wishes to sit with you. Do not touch anyone and keep your hands to yourself.
- * To prevent injury should the bus come to a sudden stop, please remain in your seat and face forward.
- Screaming and fighting are serious distractions for your bus driver. Please be pleasant to your bus mates.
- * Never throw items around in the bus. You could hurt yourself or others!
- Never leave your book bag or sport equipment in the isle. Fellow bus mates may trip and fall.
- * Never stand up when the bus is in motion. Wait for it to come to a complete stop before getting out of your seat.

- * Never stick your head, arms or other appendages out of the windows.
- * Never forget your book bag, sporting equipment or any other items on the bus. Especially if you will need them for the day.
- * When exiting the bus, wait for the bus to come to a complete stop before attempting to exit the bus.
- * Walk slowly and be patient while getting off the bus.
- * Once you are off the bus, walk directly to the curb.
- * Cross the street at least 10 feet in front of the bus and wait for a signal from the bus driver that it is safe to cross.

Preventing Bullying on the School Bus



BULLIES choose the school bus as their prime location for picking on their peers, because the school bus is an ideal location. Mainly because supervision is generally minimal. Before boarding the bus, the rush to get on the

bus and other activity makes the tactics of a bully hard to notice. On the bus, the only adult may be the driver, who is unable to respond to every incident because he / she is operating the bus. Akwesasne is lucky enough to have Bus Monitors that assist our bus drivers in the monitoring of the bus activities.

School buses are the main source for of transportation in Akwesasne, so students have no choice but to ride the bus. This makes them easy targets for bullies. Space on the school bus is limited, closed in and victims of bullying have no place to escape. A bullies' intimidation and physical abuse becomes frequent. We would like make parents, teachers and other students aware of these problems and how to prevent them for the safety of everyone on the bus.

Signs of Bullying

Students who are being bullied may not be willing to approach adults for help because they are concerned with being labeled weak or tattle-tales. However, adults can recognize signs of bullying - whether it is on the bus, on the playground or in the classroom - to help them know when children may need help. Bus bullying signs include:

- * Fear of going to school or of riding the bus.
- * Habitually delaying or otherwise deliberately trying to miss the bus.
- * Continually asking for rides to school or finding excuses to ride with friends instead of on the bus.
- Ripped clothes, missing possessions or signs of physical abuse that a teacher is unable to report happening in class or at school.

Reacting to Bullying

How to React to Bullying

It is estimated that nearly one in five students is subjected to school bus bullying and many parents' initial reaction may be to rush into the situation and protect their child. While this is admirable, such heroics may not help the situation because the parent cannot be present every time an incident may occur. There are steps that students and parents can take to prevent or stop school bus bullying.

RULES AGAINST BULLYING

- I. We will not bully others!
- 2. We will try to help students who are bullied!
- 3. We will included students who are left out!
- 4. If we know romeone ir being bullied, we will tell an adult!

Students can...

- * Sit as close to the bus driver as possible and on the right-hand side of the bus so they are visible to the driver.
- * Pair up with a neighborhood friend and ride the bus together.
- * Be polite to someone who tries to bully them rather than reacting with anger; fighting back should never be an option and will only make the situation worse.
- * Tell adults when bullying happens, including parents, teachers and the bus driver.
- Stand up for other students who are being bullied to keep it from spreading.





Parents can...

- * Check the school's bullying prevention policies and report incidents to the proper officials.
- Keep the student's name confidential to avoid increased bullying.
- * Be a good listener to encourage the child to tell adults if an incident occurs.
- * Teach responsible bus riding behavior.
- Be a good role model by avoiding road rage and other driving related intimidation tactics.
- * Avoid blaming the child for being bullied.
- * Avoid encouraging retaliation or fighting and focusing on positive bullying prevention methods instead.
- * Investigate alternative transportation such as car pooling, biking, walking or a different bus route if possible.

In cases of extreme bullying, even these tactics may not be enough to protect children from physical, verbal and emotional intimidation. There are, however, other ways parents can get involved to end this harassment. If this is the case, please talk to the AMBE Director.
