## UNOFFICIAL RESULTS OF AKWESASNE ELECTION LAW REFERENDUM AEL# 2024-01, MCR 2024/2025 #101 SEC. 16.2 (A)

The Chief Referendum Officer (CRO) hereby notifies the community of the "unofficial" results of the Akwesasne Election Law Number 2024-01, MCR 2024/2025 -#101 Sec. 16.2 (a) referendum held on Saturday, January 31, 2026.

**The 'unofficial' results are as follows:**

Therefore, the Akwesasne Election Law Section 16.2 (a) is hereby declared to have passed.

## COMMUNITY UPDATE ON ICE-RELATED CONCERN IN THE AREA

The Mohawk Council of Akwesasne (MCA) is aware of heightened concerns in our community following recent announcements and news related to United States Immigration and Customs Enforcement (ICE), including reports that St. Lawrence County has approved moving forward with a memorandum of agreement with ICE, as well as videos and information circulating on social media. Akwesasne is a sovereign territory with our own police services and law enforcement protocols. Our local authorities are committed to protecting the safety and rights of our people.

In response to these concerns, the Akwesasne Mohawk Police Service (AMPS), along with the Grand Chief and Council of the Mohawk Council of Akwesasne, are coordinating with the Saint Regis Tribal Police to meet in the near future with U.S. Customs and Border Protection (CBP) leadership and the CBP Director to discuss issues and concerns being raised in the area. MCA and our police services are actively raising these concerns and working with partners to ensure the safety and wellbeing of our community.

MCA's priority remains the safety, dignity, and wellbeing of our community members. We do not condone any actions that target, discriminate against, or disrespect Indigenous peoples or any community members.

To support personal safety and reduce stress during travel outside the community, we encourage all Akwesasrō:non to:

- Carry valid identification, including Status or Tribal ID, which is a recognized form of identification and can help establish your identity if needed
- Store emergency contact numbers in your phone
- Avoid approaching or interfering with active enforcement situations
- Rely on information shared through official MCA channels

MCA also reminds the community to be cautious when reading information online. Misinformation can increase fear, create confusion, and place community members at risk. Please rely on official updates from MCA and trusted sources.

We will continue to work with our partners, address concerns as they arise, and provide updates to the community as more information becomes available.

## JOINT STATEMENT FROM THE SAINT REGIS MOHAWK TRIBAL COUNCIL AND MOHAWK COUNCIL OF AKWESASNE ON THE NYPA PROPOSED ADVANCED NUCLEAR POWER PROJECT POTENTIAL SITE

Tsiothohrhkó:wa/January 20, 2026 — The Saint Regis Mohawk Tribal Council and the Mohawk Council of Akwesasne issue the following joint statement in response to RFQ Number Q25-7715JC, Community to Host NYPA's Advanced Nuclear Power Project:

"In the absence of support from our membership and community, the Saint Regis Mohawk Tribal Council and the Mohawk Council of Akwesasne will not provide support for the development of a nuclear power plant at any location near the Akwesasne Mohawk Territory," stated the Councils.

Historically, Akwesasne has not been adequately considered in industrial development projects. The failure to engage in this consultation has resulted in long-term environmental damage, health concerns, and a justified legacy of distrust. The Councils assert their inherent sovereignty and affirm that meaningful consultation must occur before any decisions or commitments are advanced. The protection of Akwesasne lands, waters, and people is non-negotiable, and these failures will not be repeated.

Given the close proximity of the proposed project to Akwesasne and Tribal lands, which includes the Massena Mile Square and Grasse River Meadows, and recognizing the potential impacts associated with nuclear development, the Councils have requested a formal consultation process directly with the New

York Power Authority (NYPA), separate from the public comment process.

"Direct consultation is necessary to ensure that all potential risks, benefits, and broader implications of the proposed project are fully evaluated and clearly understood by Akwesasrō:non. It is essential for our community to make an informed decision rooted in transparency, respect, and meaningful engagement. We remain cautious regarding any new industrial development that may pose risks to the health, safety, and overall well-being of our people," the Councils stated.

The Councils are aware that individuals have proposed the former General Motors Superfund Site, now under the Revitalizing Auto Communities Environmental Response (RACER) Trust, as a potential location. The Councils have received formal communication from RACER stating: "While the RACER Trust takes no position on nuclear energy generally, it is our position that a nuclear power plant should not be sited on the RACER property."

The Saint Regis Mohawk Tribal Council and the Mohawk Council of Akwesasne will continue to prioritize the health, safety, and sovereignty of the Akwesasne community and will provide updates as additional information becomes available.

## GRAND CHIEF LEONARD LAZORE UPDATES



### NOVEMBER GRAND CHIEF UPDATES

#### Border Partners Meeting

- New Liaison: A new liaison from Tribal PD will be appointed for the Massena Port of Entry, with contact information to be shared via email, and in-person introductions are planned.

#### DIHE Housing Sector Updates

- Biometric Collection Delayed: The December 26 biometric collection for the land border at Massena is anticipated to be delayed for "a couple of years," but the community stressed the need for full consultation before any future rollout.
- CBSA Communications & Recruitment: CBSA is working to improve real-time communication during border delays and have hosted a local recruitment event on November 24-25, 2025, with a recommendation for local hires.

#### Transport Canada Meeting

- The meeting focused on the Mohawk Council of Akwesasne's interest in acquiring surplus lands from Transport Canada, primarily for housing development. Further meetings are to be held, along with community consultation before actions are taken towards this project.

#### Ontario Fire Management Update Meeting

- The 2025 fire season was one of the worst in recent history, characterized by an early start in April, extensive drought conditions, and an almost 200,000-hectare record-breaking single fire (Red 12). Resource availability was a significant challenge due to simultaneous fires across Western Canada.
- There's a growing focus on improving fire management agreements with First Nations, developing Indigenous Community Liaison training, and fostering cultural fire discussions. The Ministry

of Emergency Preparedness and Response (MEPR) is actively supporting Indigenous-led emergency management through training, partnerships, and a recent Flood and Wildland Fire Symposium focused on mental health and resilience.

#### DIHE Housing Sector Updates

- Housing Authority Composition Changes: District Chiefs to attend meetings in individual status, not board members.
- Grand Chief's Role: Confirmed ex-officio, can attend all meetings.
- Executive Director's Role: Executive Director to attend meetings.
- Voting Rights Discussion: Chiefs and staff should not have voting rights; technicians and community members can.

#### Transport Canada Meeting

- Chairperson as Tie-Breaker proposed for voting disputes.
- Chiefs' Sponsorship Role: Chiefs should sponsor MCRs and answer questions without technical staff.
- Section 95 Issues: Discussed concerns about subletting, non-original tenants, and lack of enforcement.
- Good Standing Policy Flaw: Discussed the Good Standing Policy; not catching issues such as unpaid water bills from MCR-non-affiliated departments.

#### Cornwall Lands Purchase

- Mohawk Council of Akwesasne aims to purchase Cornwall lands. Mediation and remediation assessment studies conclude by March 2026.
- The letter of intent to purchase will be presented to Canada on November 13, 2025.
- Extensive community engagement is planned before major decisions, potentially including a referendum.

## GRAND CHIEF LEONARD LAZORE UPDATES

Lands Canada for quicker land transfer and development, with a meeting scheduled for December 1, 2025.

- Remediation Concerns: Only a small portion (10-20 acres) of the 150-acre property is expected to require remediation.
- Local Expertise: Preference for local consultants and engineering firms in Cornwall for development projects.
- Financial Strategy: Focus on securing external funding (foundations, government programs, conventional banks) before using community dollars.

#### Implementation of Council Internal Strategic Planning Sessions

- Council met together to discuss in detail the plans to address the needs of the community and strategize best efforts to address those needs in an open discussion. These meeting will be held regularly in addition to Council Meetings held every Monday.

#### MCA Community Holiday Dinners

- The Mohawk Government office put together three Holiday Dinners for the community in each district where all of Council attended, served, and engaged with the community over good food and warm treats.



#### Introductory Meeting with Cornwall City Council and Mayor Townsdale

- Attended an introductory meeting with full council to meet with Cornwall City Council and Cornwall Mayor Justin Townsdale, with the intention to meet quarterly. There were discussions about collaborative efforts with the

Mohawk Council of Akwesasne and the City of Cornwall on economic, health, housing and social services.

#### Iroquois Caucus Meeting (Virtual)

- The Iroquois Caucus is undergoing a structural "leveling up" to transition from a discussion-based forum to an action-oriented political entity.

### GRAND CHIEF TRAVEL

#### Chiefs of Ontario Quarterly Meeting | Toronto, ON

- Day 1: Attended information sessions regarding resolutions covering First Nations off-reserve housing, Indian Act Discrimination and reform efforts, new policies for Indian gaming, drug toxicity crisis and Indian Welfare Agreement, and Chiefs of Ontario AFN participation.
- Day 2: Attended information sessions on the First Nations Clean Water Act Advocacy, Justice Sector Update, and the Ontario Final Agreement.

#### IESO First Nations Energy Symposium | Toronto, ON

- Attended sessions and discussion panels regarding creating and sustaining Indigenous Energy Projects, the impact of fast-tracked legislation, and Indigenous Partnerships and Project Development.

#### Assembly of First Nations Quebec-Labrador (AFNQL) | Toronto, ON

- Met with other AFNQL members and attended sessions and discussions on the evolution of First Nations policing and public safety strategies within Quebec, current bills relevant to Indigenous communities, the Quebec Constitution, National Children's Chief Commission final settlement agreement.

#### Iroquois Caucus | Ottawa, ON

- Met with the Iroquois Caucus to dis-

cuss issues such as treaty reform and trade rights, like the Marshall Decision, ahead of the Assembly of First Nations Special Chiefs Assembly.

#### Assembly of First Nations Special Chiefs Assembly | Ottawa, ON

- Attended plenary sessions and voted on resolutions regarding Bill S-2, Long Term reform of First Nations Child and Family Services and Jordan's Principle, Major Projects Office, Infrastructure and First Nations Bank of Canada.

#### Chiefs of Ontario Quebec Caucus | Ottawa, ON

- Met with other First Nations leadership throughout Ontario and discussed the Canadian federal government's recent announcement by the Prime Minister. The meeting also highlighted the imminent return of 61 artifacts from the Vatican to Montreal and expressed significant leadership frustration regarding federal budget cuts and the Prime Minister's perceived lack of respect toward regional Chiefs.

#### Chiefs of Ontario Leadership Council Meeting | Toronto, ON

- Attended sessions and engaged with presentations from the Ontario Ombudsman Paul Dube, ALTO on the proposed High Speed Rail and C.E.C. Innovations and Whirlwind Enterprises.




## HAVE A CONCERN AT YOUR STUDENTS AMBE SCHOOL?



## Registration under the Indian Act and applying for a status card, what's the difference?

*Registration under the Indian Act is not the same as applying for a status card. This infographic helps explain the differences.*

### REGISTRATION

### STATUS CARD

<p><b>What is it?</b> Your legal status as a person registered under the Indian Act.</p>	<p><b>What is it?</b> A government-issued identity document that confirms you are registered under the Indian Act.</p>
<p><b>How long does it take?</b> It usually takes less than 6 months to process a complete application for registration under the Indian Act. However, in some cases, it may take up to 2 years or more.</p>	<p><b>How long does it take?</b> Once you are registered under the Indian Act, a laminated status card can be prepared the same day as your appointment at the OVS office.</p>
<p><b>How do you register?</b> You can apply for registration <a href="#">by mail or in-person</a> at any <a href="#">regional office</a>, or through a <a href="#">trusted source</a>, or your <a href="#">First Nations office</a> if they offer registration services.</p>	<p><b>How do you apply?</b> You can make an appointment at the Office of Vital Statistics to apply for a laminated Certificate of Indian Status.</p>
<p><b>Does it need to be renewed?</b> No. Registration doesn't need to be renewed.</p>	<p><b>Does it need to be renewed?</b> A laminated status card needs to be renewed every 5 years for adults and dependent adults and every 3 years for children.</p>
<p><b>Is there a fee?</b> There's no fee to apply for registration, but there may be a fee for some required documents, for example, a proof of birth document.</p>	<p><b>Is there a fee?</b> There's a fee of <a href="#">\$5.00</a> for the status card which will be waived if you hand in your old status card, and a <a href="#">\$5.00</a> fee for a photo unless you provide your own printed photo. There are no fees for elders aged 60 or above.</p>

# EMERGENCY MEASURES PROGRAM



## HAZARD HELP SHEET WINTER DRIVING

### WINTER DRIVING

Winter travel by automobile can be serious business. Be prepared. If you do a lot of winter driving in isolated regions, you might want to consider keeping your car radio tuned into a local weather channel. Along with colder temperatures, snow, and ice, winter also brings potentially dangerous driving conditions. Slippery roads and decreased visibility can make driving in Canadian winters a challenge. Winter driving calls for extra care, even in normal winter conditions. Snow and ice can reduce tire traction on roads and heavy or blowing snow can make visibility poor.

#### WINTER TIRES

If you haven't already, please take the time to get your winter tires on your vehicle. If your vehicle is registered in Quebec, it's the law.

#### SLOW DOWN

Fog, black ice, slush or snow-covered roads can make driving dangerous. Drive slowly and leave plenty of distance between your vehicle and those vehicles in front of you. If the roads are icy, slushy or slippery, please avoid passing other vehicles.

#### SEE AND BE SEEN

Clear all snow from the hood, roof, windows and lights. Clear all windows of fog or ice. If visibility becomes poor, find a place to safely pull off the road as soon as possible.

#### AKWESASNE ICE BRIDGE

The 'ice bridge' that connects Kana:takon to Tsi Snaihne (and to Kawehno:ke) is **NEVER** the safest route. Though it may be convenient and time saving, please avoid using this model of travel. Keep your family safe and avoid using the ice bridge.

#### STAY ON THE MAIN ROADS

If you must stop your vehicle, pull over at a rest/text stop. Use a bright distress flag or your hazard lights to draw attention to your vehicle.

#### AAA/CAA

If you are a member of AAA or CAA, you're in luck. These memberships have various benefits for helping their members when they are in most need and some costs are still reimbursable.

#### EMERGENCIES

Should you find yourself in an emergency situation, call 9-1-1 and request emergency assistance.

#### KEEP CONTROL OF YOUR VEHICLE TO AVOID COLLISIONS

Winter collisions can occur when your vehicle skids. Remember that not all vehicles respond in the same way to icy, slippery roads. You must know how to handle your vehicle and how it responds in various weather conditions. Review your owner's manual and familiarize yourself with your vehicle's braking system and tire traction. You may also consider attending a safety driving course.

#### IF YOU ARE TRAPPED (IN A BLIZZARD)

Clear your tail pipe and run your engine and heater for ten (10) minutes every hour. Open your window slightly. However, **during night hours**, keep the dome light on in your car so rescue crews can see your vehicle.

While the games were competitive, it was important to note all participants had a great time, sharing plenty of laughs, and brought life and energy to the tournament.



These viruses affect the lungs and throat, and they spread easily through coughs, sneezes, or close contact with an infected person.


Symptoms of COVID-19, flu, and RSV can be very similar, it may be difficult to tell them apart. Common symptoms may include:

In an effort to avoid further incidences of poisonings, Mental Health & Wellness Addictions Services is providing the following information:

### Signs and Symptoms of Overdose

- Difficulty walking, talking, or staying awake
- Blue, purple or grey lips or nails
- Very small pupils
- Cold and clammy skin
- Dizziness and confusion
- Extreme drowsiness
- Choking, gurgling, or snoring sounds
- Slow, weak, or no breathing
- Unresponsive (unable to wake up, even when shaken or shouted at)

### What to do if Someone is Overdosing

- Shake them, shout their name, and rub their sternum with your knuckles

## AMPS ENCOURAGES SAFE PRACTICES FOR ALL-TERRAIN VEHICLES

The Akwesasne Mohawk Police Service (AMPS) is reminding community members about the importance of safe and responsible All-Terrain Vehicle (ATV) use. While ATVs are a popular way to enjoy the outdoors, unsafe operation can pose serious risks for riders, passengers, and the community.

Over the past weeks, AMPS has received complaints related to unsafe ATV operation, including excessive speed, noise, operating on private property, and riding in unsafe areas. These activities not only endanger riders but also compromise community safety and quality of life.

When actions put oneself or others at risk, enforcement measures will be taken.

ATV Safety Reminders for Akwesasne to remain compliant with the Community ATV By-law #1993-1994-01

- NO operation of an ATV between the hours of 11:00 p.m. to 6:00 a.m.
- Only a valid licensed driver with insurance may operate an ATV on a roadway.
- Youth riders should be supervised and only operate ATVs suited to their age and size.
- The driver MUST drive half the posted speed limit. Failure to do so will result in a speeding fine.

- All occupants MUST wear a helmet. Failure to do so will result in a fine of \$75.00 for "inadequate head protection".
- When operating on the roadway, the ATV MUST be registered and insured.
- Failing to stop for police may result in a criminal code charge.
- A registration form for the ATV must be completed and can be obtained from the Akwesasne Justice Department

Administration Office (45 Johnson Road, Kana:takon). License plates are also available at this location.

Restorative justice practices will be implemented, however repeat or dangerous violations, will result in fines or enforcement actions. Together, we can ensure ATV riding remains lawful, safe, and respectful in Akwesasne.

The Akwesasne Mohawk Police Service remains committed to focusing its efforts on fostering positive relationships with our community members. We encourage community support and involvement to report any suspected criminal activities. Anyone with information that would assist in any type of investigation can call Central Dispatch at 613-575-2000.

- Consider the impact of unverified information on individuals, families, and the broader community.
- Recognize the role each of us plays in ensuring the physical, emotional, and reputational well-being of those around us.

We appreciate the vigilance and care of the public. We are working diligently together to share accurate and timely information when possible. Your support in reporting accurate, fact-based information helps us keep the community safe and united. Together, we can ensure that our responses are guided by facts, not fear.

## FIRE PROTECTION STRATEGY WORK UNDERWAY

The Mohawk Council of Akwesasne's Emergency Measures Program is beginning work on the Fire Protection Strategy, a community safety initiative focused on reducing fire risks across the territory.

Please be assured that this activity is for safety and planning purposes only, there is no cause for concern or alarm. The photographs are strictly being used to support fire prevention planning and future safety measures.


